SET-UPS AND UNLOADING

Unloading zone will open at 6:15 am. All vehicles are to be removed to the parking lot as soon as they are unloaded.

- Personal tents and generators will only be allowed in designated areas.
- **No exercise pens under Club supplied tents**
- No exercise pens or set-ups within 20 feet of the rings or in the Fire Lanes.
- No exercise pens or set-ups in any Day of Show Parking lot.
- All dogs on grooming loops must be attended at all times.
- **No vehicles or vehicle traffic will be allowed on the show grounds for loading or unloading.**

ATTENTION EXHIBITORS

Gas stations and grocery stores are in Escondido, 8.1 miles from show grounds.

This show site has a **No Smoking and No Alcohol Policy**. Please help the club retain this show site by following these rules.

All exhibitors will be held responsible for the clean-up of their dogs. This includes all aisles, all surrounding areas, all parking lots, hotels and motels. Please put all trash in the proper receptacles. Any exhibitor who does not adhere to these rules may be subject to disciplinary action.

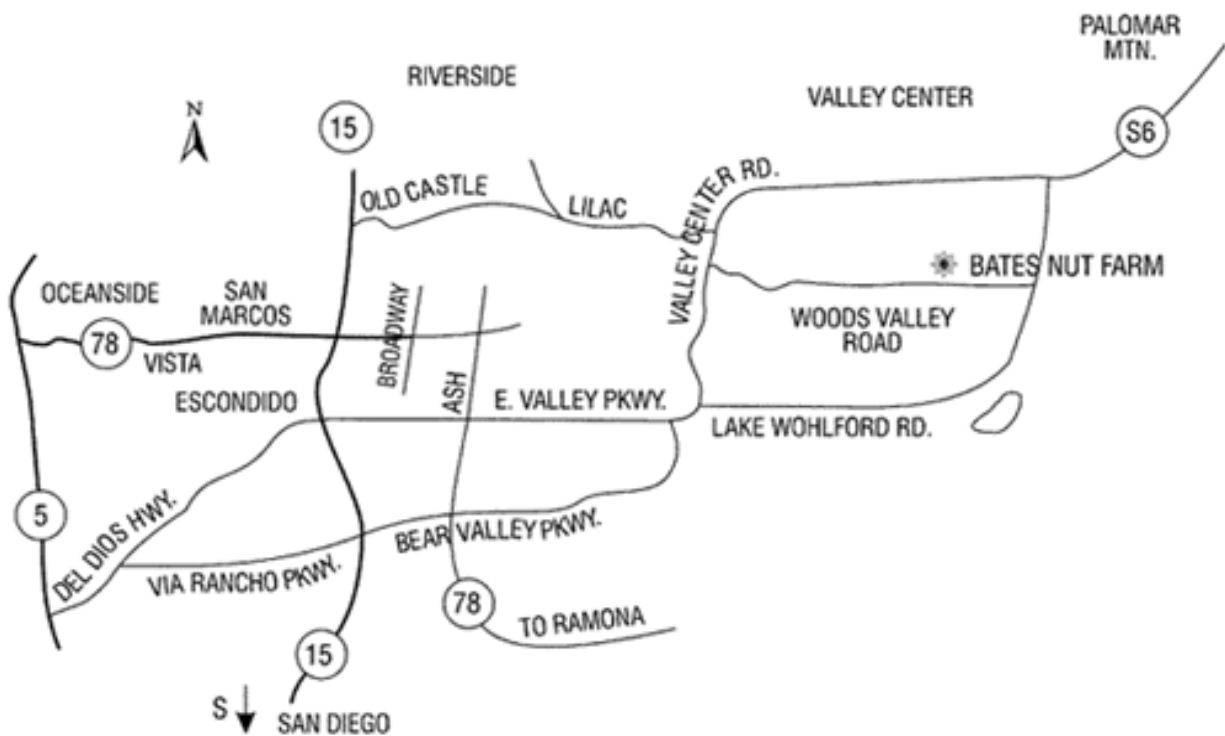

DIRECTIONS TO SHOW GROUNDS

From I-5 North or Southbound: Take Hwy 78 East. At Exit 17C, head on the ramp right and follow signs for Centre City Pkwy. Turn right onto W El Norte Pkwy. Go East 3.8 miles to E Valley Parkway. Turn left, go 4.2 miles on E Valley Parkway which will become Valley Center Road and turn right onto Woods Valley Rd. Go 3.2 miles and turn Left into Bates Nut Farm.

From I-15 Southbound: At Exit 41, take the ramp for Gopher Canyon Rd toward Old Castle Rd. Keep straight to get onto Gopher Canyon Rd. Turn right onto Champagne Blvd then left onto Old Castle Rd for 5.5 miles. Keep straight to get onto Lilac Rd for 3.3 miles. Turn right onto Valley Center Rd for 1.2 miles. Turn left onto Woods Valley Rd for 3.2 miles and turn Left into Bates Nut Farm.

From I-15 Northbound: Take Exit 27, Via Rancho Pkwy, East toward San Diego Zoo Safari Park. Road name changes to Bear Valley Pkwy. In 4.4 miles, turn right onto E Valley Pkwy. In 4.8 miles turn right onto Woods Valley Rd. Go 3.2 miles and turn Left into Bates Nut Farm.



DEL SUR KENNEL CLUB COVID-19 SELF-DECLARATION and WAIVER

If you will be at the Del Sur Kennel Club (DSKC) for any of the AKC Events in any capacity, you must complete this Self-Declaration and Waiver of Liability **PRIOR TO ARRIVAL** to gain entry and obtain your entry wrist band that you **MUST** wear each day and show upon entering the facility. A separate form is required for each individual, including minors.

This includes, but is not limited to, exhibitors, owners, handlers, breeders, assistants, superintendents, judges, stewards, vendors, any providers of services and their staff and volunteers. There are no exclusions or exceptions.

I attest to the following:

_____ **Initials** I affirm that within the last 14 days, I have not experienced any of the symptoms related to COVID-19 nor have I taken medication to reduce fever during that time. Common symptoms include fever, cough, runny nose, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, sore throat, nausea or vomiting, diarrhea and/or loss of sense of smell or taste. These symptoms do not include those attributed to another health condition that you normally experience.

_____ **Initials** I affirm that within the last 14 days, I have not tested positive for COVID-19.

_____ **Initials** I affirm that within the last 14 days, I have not been in close contact (being within six feet of an infected individual for at least 10 minutes) with any individual who has tested positive for COVID-19.

_____ **Initials** I affirm that within the last 14 days, neither I nor anyone with whom I have been in close contact (being within six feet of an infected individual for at least 10 minutes) are waiting for results of a COVID-19 test.

_____ **Initials** I affirm that within the last 14 days, I have not cared for someone showing any of the symptoms of COVID-19.

_____ **Initials** I affirm that I am not under any self-quarantine orders.

_____ **Initials** I affirm that I have read the DSKC face mask rules and understand that I will be required to **properly** wear a mask at all times while on the event grounds.

_____ **Initials** I agree to fully comply with: (i) any health and safety protocols and mitigation measures implemented by the DSKC and (ii) all local, state and federal requirements, each of (i) - (ii) as amended from time to time, while on the event grounds.

_____ **Initials** I agree that if my health should change while attending the AKC events at the Del Sur Kennel Club, I will immediately leave the event and facility and seek medical guidance.

_____ **Initials** I agree that if I test positive for COVID-19 or am exposed to someone who has tested positive for COVID-19, I will notify the Club promptly and will not reenter the Del Sur Kennel Club event grounds.

If you cannot affirm or agree to ANY of the above statements, DO NOT come on to the event grounds.

I am fully and personally responsible for my own safety and actions while and during my participation and I recognize that I may be at risk of contracting COVID-19 or other communicable infection. With full knowledge of the risks involved, I hereby release, waive and discharge the Del Sur Kennel Club, its board, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death that may be sustained by me while participating in any activity while in, on, or around the premises or while using the facilities at Bates Nut Farm that may lead to unintentional exposure or harm.

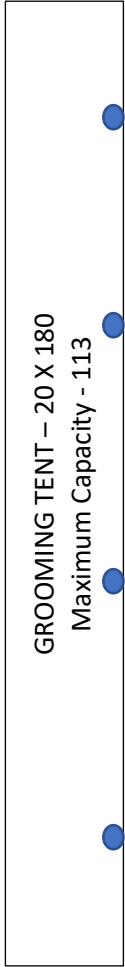
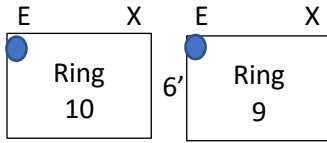
DEL SUR KENNEL CLUB – SITE LAYOUT



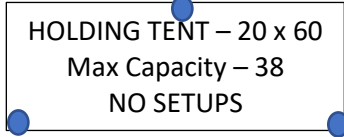

HOLDING TENT – 10 x 30

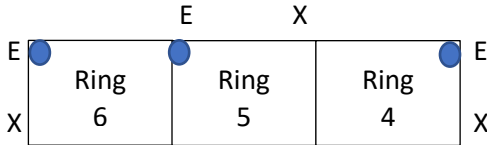

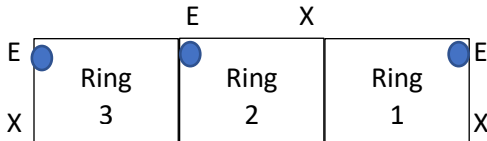

● Hand Sanitizer Stations - 24

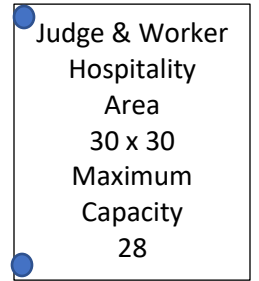
● Hand Wash Stations - 3
