POINTS FOR RESERVE

The Boston Terrier Club of America, Inc. will award at its National Specialty a three point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held.

The Boston Terrier Club of America, Inc. will award at its National Specialty a three point major to Reserve Winners Bitch if the Regular Class Bitch entry is twice the required number for a five point major in the division where the National Specialty is held.

BEST OF BREED COMPETITION

NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

Veteran (divided by sex) – 7 years and under 10 years; 10 years and older

Entries in the Veteran Classes may be spayed or neutered. The winners in these classes are eligible to compete in Best of Breed provided they are undefeated in any other class.

NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES (Winners not Eligible for Best of Breed)

Stud Dog Class - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class – Same as Stud Dog, except substitute Brood Bitch for Stud Dog and produce for Get.

Stud Dogs may be neutered and Brood Bitches may be spayed.

BRACE CLASS - A Brace is defined as two dogs of the same recognized breed that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in Brace Competition must have at least one common owner. The dogs comprising a Brace MUST be named at the time of entry. Dog MUST be entered in another class and Brace MUST be marked accordingly in the space provided for Additional Classes - "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace unit must be so designated - "Brace No. 1," "Brace No. 2," etc. PLEASE SUBMIT BRACE ENTRIES TOGETHER.

TEAM CLASS - A Team is defined as four dogs of the same recognized breed that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in Team Competition must have at least one common owner. The dogs comprising a Team MUST be named at the time of entry. Dog MUST be entered in another class and Team MUST be marked accordingly in the space provided for Additional Classes - "Team Class". If more than one Team is entered by the same owner, the dogs comprising EACH Team must be so designated - "Team No. 1," "Team No. 2," etc. PLEASE SUBMIT TEAM ENTRIES TOGETHER.

Exclusive Video Policy & Release

The professional video services and live streaming at this show are governed by an exclusive video contract with the Club. No other commercial video recording, video recording from a tripod, monopod or other supported camera/device, or any video recording or streaming of large parts or whole classes shall be permitted. The contract terms permit individuals to record small bits of video of their own dogs only, and using handheld devices only (e.g. phone, tablet or small camcorder). Individuals may post recorded videos of their own dogs to social media (Facebook, YouTube, etc.). However, during show hours LIVE Broadcast Streaming to social media (e.g., Facebook Live) is not permitted. Submission of an entry form and/or physical presence on the show grounds shall constitute both implied and real consent for both the handler and the dog to be professionally video recorded and streamed live only by the professional video services as contracted by the Club for this show.

All rights to video record and live stream or otherwise exploit this event and/or the persons or animals participating in it, including the names, likenesses and biographical matter of dogs, owners, handlers, breeders and kennels participating in the event shall belong solely to the show giving Club and/or the American Kennel Club, Inc. No spectator, participant, owner, handler, breeder or kennel shall make commercial use of any video recordings of any person or animal participating in this event without prior written approval from the Club. This event may not be broadcast to social media (e.g. Facebook Live, etc.) without prior written approval from the Club.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Novice Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Novice Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Master Class: For boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors Meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Each dog handled in a Junior Showmanship Class must be entered in one of the Breed or Rally Classes at the show or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC go online at www.akc.org.

Junior Handler's must include their AKC Junior Handler identification number on the entry blank.

You may obtain your number by calling the AKC (919) 233-9767. Notice: Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.

Suggested Best Practices for the Well-Being of Dog Sport Participants



General Practices

1. Clubs, officials and participants are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
2. Practice social distancing consistent with guidelines in effect at the time of the event. Avoid congregating to the extent possible.
3. Consider wearing masks when in close proximity to others. Clubs should provide masks if desired for officials, judges and volunteers.
4. Consider wearing disposable or washable gloves.
5. Wash hands as frequently as possible. Have disinfecting spray at bathroom facilities for people to spray door handles (or anything else they touch). Consider hiring bathroom attendants to maintain maximum cleanliness.
6. If you utilize portable toilets, please ask for a hand washing station(s) to be delivered as well.
7. Avoid shaking hands, hugging, or other physical contact.
8. Avoid touching dogs that are not your responsibility.
9. Avoid common use pens/pencils – bring your own.
10. Disinfect surfaces in common use areas as often as possible (tables, chairs, doorknobs, etc.) Clubs and facilities may consider not providing chairs.
11. Meals - Avoid or stagger group lunches/dinners if possible.
12. Vendors should follow retail guidelines for the area.
13. Parking – Park with sufficient distance between vehicles if possible. If there is a parking fee, ask exhibitors to bring exact change.
14. Indoor show sites should work with facilities to have as many entrance/exits points open as possible. Hand sanitizer should be available at every entrance to the site and at multiple locations within the site.
15. Parking/unloading staff should wear masks and sanitize their hands following the assistance of each individual.

ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw by *Noon, Wednesday May 5, 2021 PT.* Fees should accompany entries. This club and/or its superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a cash only basis. The returned check or declined credit card must be made good by cash or money order before the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. Please bring your identification tickets to the show.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7:30 a.m. to 6:30 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available online at www.akc.org.
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitors' setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club.
9. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$4.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at this show.
11. Declination of Entries. The Boston Terrier Club of America may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half hour prior to the start of the earliest Conformation judging at the Show.
15. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
16. No practicing allowed in rings at any time.
17. Parents and/or Guardians are responsible for the actions of their children.
18. By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present and agree not to hold the superintendent liable for any illness or injury.
19. By attending this event, you voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Jack Bradshaw Dog Shows, its owners, employees, or volunteers liable for any illness or injury.

Sweepstakes

Requirements

Sweepstakes is open to all Boston Terriers 6 months and under 18 months of age, provided they are not Champions of Record or have finished their championship according to their owner's records.

Professional Handlers may show. Dogs shown in Sweepstakes MUST ALSO be entered in one of the regular classes at the regular entry fee and on the regular entry form. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class."

Classifications

The following classes will be provided for both dogs and bitches.

Futurity Rules

PURPOSE

The purpose of the Boston Terrier Club of America, Inc. Futurity is to encourage the breeding of the best possible Boston Terrier, reward diligent breeders for their efforts, recognize the owners for selecting the best quality puppies from responsible breeders, and reward the owners and breeders for raising and developing the inherited qualities of the puppy.

I. GENERAL

- A. Correct and timely nominations of both the litter and the individual puppy are required for stake eligibility.
- B. Prize monies can only be won through competition at the Boston Terrier Club of America, Inc. National Futurity Stakes held in conjunction with the Boston Terrier Club of America, Inc. National Specialty.
- C. Nomination forms may be secured from the Futurity Director.
- D. Nomination and entry fees cannot be paid by credit card.
- E. The Futurity Director and committee members are eligible to participate in Futurity Competition.

II. NOMINATION OF LITTER

- A. Nomination must be made by breeder or co-breeder. The person making the nomination must be a Boston Terrier Club of America, Inc. member.
- B. Nomination must be made after breeding, but before puppies are whelped. The postmark on the entry envelope is the official date of nomination.
- C. The fee to nominate the litter is \$25.00. There will be no refunds.
- D. The nomination of a litter makes all puppies in the litter eligible for individual nomination.

III. NOMINATION

A. PUPPY

- I. Nomination must be made by the legal owner or co-owner of the puppy as of the date of nomination.
- II. Nomination must be made on or before four (4) months of age. The postmark on the envelope is the official date of nomination.
- III. The fee is \$20.00 for each puppy nominated. There will be no refunds.
- IV. An entire litter may be individually nominated by the breeder before puppies are sold by paying fee for each puppy and supplying whelping date, name, sex and color of each puppy. If neither litter registration number or individual registration number is available at the time of nomination, this must be supplied as soon as available and in no case later than nine (9) weeks before the stakes judging.
- V. Any changes in the identifying information which will be included in the catalog must be received by the Futurity Director six (6) weeks prior to Futurity judging. Failure to provide such information will result in disqualification.
- VI. The sire of all puppies nominated must also be nominated for this event.

B. STUD DOG

- I. All Stud Dogs must pay a one-time annual nomination fee. The nomination is good for one year following the postmark date on the envelope and covers all litters sired the dog during the year.
- II. Fee is \$25.00 for each Stud Dog nominated.
- III. Stud Dog nomination fee must be paid prior to whelping of litter.
- IV. At least one owner of Stud Dogs must be a member of the Boston Terrier Club of America, Inc.

V. REQUIREMENTS TO ENTER JUDGING

- A. The puppy must be entered in one of the regular classes, either in conformation or obedience at the Boston Terrier Club of America, Inc. National Specialty Show. All entries must be paid in full.
- B. Futurity entry must be indicated as an additional class.
- C. Futurity entry must include age division (e.g., Futurity 6-9, etc.)

D. Futurity Classes range in age from six (6) months and up. The classes will be 6-9 Mos., 9-12 Mos., 12-15 Mos. and 15 Mos. & over.

E. Puppies are eligible only for the first Futurity Stake Show that is held in conjunction with the first Boston Terrier Club of America, Inc. National Specialty Show held on or after the date the puppy reaches six (6) months of age.

F. Individuals handling the dogs in Futurity Competition are limited to the breeder or co-breeder, the owner or co-owner or members of their immediate families. Immediate family is defined as husband, wife, son or daughter.

G. In the event that a member has two or more eligible puppies to be shown in the same class, one puppy can be shown by an alternate person that is not a professional handler as defined by AKC.

VI. SELECTION OF JUDGES

A. Nomination of Futurity Judges will be limited to the participants in the Futurity.

B. Each breeder who has submitted a Bitch Nomination (co-bred litters, one vote per bitch nomination by primary owner as recorded by AKC) will be given the opportunity to suggest two names of possible judges on each bitch/litter nomination form.

C. When it is determined that no more nominations may be made for that year's futurity event, the Futurity Director will send a ballot with the top six possible judge's names to each breeder who nominated a litter.

D. Each breeder will receive one ballot for every three litters nominated with no breeder submitting more than 2 ballots. Each ballot will be placed in a sealed envelope by the breeder and mailed to the Futurity Director. Each nominee will be contacted verbally and must submit in writing their acceptance as a possible candidate within 10 days of verbal contact. All confirmed nominees may submit entries for competition in this event. However, the winners of Judge Draw will be required to withdraw their entries and will be refunded their money. Futurity judges may not exhibit on day(s) they judge. Per AKC Rules, Futurity judges are allowed to exhibit the day before and the day after the event they judge. A multi-day specialty is considered one event, and the restriction will apply for the duration of the event.

VII. CLASS DIVISIONS

A. Stake is divided into four age divisions:

Puppy Dogs, 6 months & under 9 months	Puppy Dogs, 9 months & under 12 months
Junior Dogs, 12 months & under 15 months	Junior Dogs, 15 months & over

B. Each age group is then divided by sex.

C. Four placements are made in the judging of each class.

VIII. SEQUENCE OF JUDGING

A. Judging sequence will be Dogs divided by age division, then Bitches divided by age division.

B. Best Puppy and Best of Opposite Sex to Best Puppy are selected from the 6-9 Mos. and 9-12 Mos. class winners.

C. Best Junior and Best of Opposite Sex to Best Junior are selected from the 12-15 Mos. and 15 Mos. & over class winners.

D. The Best Puppy and the Best Junior compete for Grand Prize Futurity Winner. If the Best of Opposite Sex Puppy and Best of Opposite Sex Junior are of the same sex, they shall compete for the Best of Opposite Sex to the Grand Prize Futurity Winner. If they are different sexes, the dog or bitch that was awarded Best of Opposite Sex to the Division Winner (who is now the Grand Prize Futurity Winner) shall re-enter the ring to compete with the remaining Division Winner (of his or her own sex) for Best of Opposite Sex to the Grand Prize Futurity Winner.

IX. DIVISION OF FUTURITY STAKE MONIES

A. GENERAL

I. 30% to operating expense fund. In the event there is any remaining funds, all left over funds will be submitted to the Challenge Trophy Award Fund.

II. 70% to be divided equally between the puppy and junior stakes.

B. DIVISION OF INDIVIDUAL STAKE MONIES (PUPPY AND JUNIOR)

I. 80% to placements in the eight classes, with

A. 40% going to first place

B. 30% to second

C. 20% to third place

D. 10% to fourth place

II. 7% to be divided equally between the Best Puppy & Best Junior with 3.5% going to each.

III. 3% to be divided equally between the Reserve Puppy & Reserve Junior with 1.5% going to each.

IV. 10% to Best in Futurity Stakes.

X. DIVISION OF PRIZE MONEY

A. At least one breeder, one owner and one stud owner must be members of the Boston Terrier Club of America, Inc. at the time of the event for eligibility to receive prize money.

I. 40% to Breeder

ii. 30% to Owner

iii. 30% to Stud Dog Owner

xi. TROPHIES AND ROSETTES

A. A Trophy and Rosette will be provided for Best Puppy, Best Junior and the Best in Futurity Winner from the Futurity operating funds.

B. Other Trophies and Rosettes may be awarded at the discretion of the National Specialty Futurity Committee.

C. Rosettes will be awarded for each placement.

xii. RECORDS

It is recommended that those who have made entries in the Futurity Stakes have copies of all pertinent information regarding acceptance of nominations, name changes, etc., available at time of judging.

xiii. SUMMARY OF MAJOR RULES

1. Litter must be nominated before litter is whelped.

2. Puppy must be nominated on or before puppy reaches four (4) months of age.

3. Stud Dog must be nominated.

4. Futurity is an additional class at the National Specialty and the entry must so indicate.

5. All information on entry form must be consistent with what was supplied to the Futurity Director.

6. Entry is open to all legally eligible dogs.

7. The postmark on the entry envelope is the official date of nomination.

- **Based on current information and clinical expertise, older adults and people of any age who have serious underlying medical conditions (heart disease, chronic lungs disease, asthma, diabetes, etc.) might be at higher risk for severe illness from COVID19 and should not attend the Event**

General Event Layout & Logistics

1. Club members, officials, vendors and exhibitors will be required to follow all CDC guidelines, State of Arizona, & City of Tucson ordinances and Westin La Paloma policies regarding COVID-19, including social distancing consistent with current guidelines.
2. Boston Terrier Club of America (BTCA) will be prepared to enforce the guidelines that apply to this event. Enforcement includes verbal warning and/or dismissal from the event.
3. This National Specialty is a private event. As is, it is only opened to BTCA members, members of BTCA affiliate clubs, and Boston Terrier Owners. All participants will abide by the BTCA's guidelines included in this Safety Plan.
4. The BTCA COVID-19 Event Safety Plan will be posted in the Premium List and on the club's website prior to the event. Additionally, the plan will be printed and included with the club's on-site AKC Disaster Plan notebook.
5. Marc Kelly, Show Chair, is the designated official as the COVID-19 Point Of Contact for this event if a person becomes sick with COVID-19 symptoms.
6. Self-monitoring COVID-19 symptoms will be required of all club members, officials, vendors and exhibitors.
7. A laser thermometer with gloves and hand sanitizer will be available at the entrance of the Ballroom.
8. If a participant reports or shows signs of COVID-19 symptoms, he/she shall withdraw immediately from the event and be instructed to go home or to a healthcare facility, depending on how severe the symptoms are, and follow CDC guidance regarding self-care. If going to a healthcare facility, the healthcare facility will be called first to alert them that the person may have COVID-19.
9. Individuals who have close contact with a person with COVID-19 symptoms at the event will be separated, sent home, and advised to follow CDC guidance for community-related exposure.
10. In accordance with state and local laws and regulations, the event's designated COVID-19 Point Of Contact shall notify the Pima County Health Department, event staff and attendees of any case of COVID-19 while maintaining confidentiality in accordance with the Americans with Disabilities Act.
11. Mandatory masks will be required for all officials, judges, volunteers, & exhibitors. Masks will be available for any person who does not have one.
12. Face shields will NOT be allowed as an acceptable alternative to face masks per CDC guidelines.
13. Hand sanitizer stations will be provided and maintained by the Westin La Paloma and placed at the separate entrances and exits to the building and multiple locations throughout the premises.
14. Hand sanitizer will be provided by BTCA at all event specific areas such as the head/trophy/catalog table, stewards tables, etc.
15. Individual hand sanitizer will be provided to all participants at the beginning and during the week of the event.
16. All common areas and frequently touched surfaces will be disinfected at least every 2 hours or less by BTCA officials and volunteers.
17. Six foot taped markers on the floor will be used around all event specific areas such as the head/trophy/catalog table, steward tables, etc. to maintain the required social distancing.
18. To minimize congestion, no congregating in the aisles will be allowed.

19. No common use pens/pencils – Exhibitors will bring their own. If needed, exhibitors will be provided new pens to use and keep.
20. Meals – No open kitchen or potluck allowed. Boxed lunches will be provided to judges and volunteers. Judges will also have the option of pre-ordering their lunch, have it delivered to their rooms during lunch breaks.
21. There will be no club's hospitality drink & snack cart at this event.
22. Food and beverages shall only be consumed while seated in spaces designated by the Westin La Paloma.
23. Attendees will not be allowed to eat at ringside.
24. Prominent signage in English will be posted throughout the building regarding hand washing, mandatory masks, social distancing, etc.
25. Frequent reminder announcements will be made regarding hand washing, mandatory masks, social distancing, etc.
26. The venue's ventilation system will be checked for proper operation prior to and monitored during the event per the Westin La Paloma. Outdoor air circulation will be increased as much as possible by opening any screened windows and doors when it is safe to do so.
27. Prior to the start of the event each day, there will be a training/educational briefing for club members, officials, vendors and exhibitors regarding the event's COVID-19 safety protocol and enforcement.
28. When an exhibitor is done for the day, they will be encouraged to leave the show venue in order to minimize congregating.

Event Practices

1. Ring Set-Up:

- Rings will be laid out to maintain the required 6 foot social distancing.
- In the conformation ring, two gates will be used, one for dogs entering and one for dogs exiting.
- Six foot taped markers on the floor of each ring will be utilized to provide exhibitors reference points for social distancing.
- Self-serve armband tables will be utilized at the ring entrances and exhibitors will be responsible for picking up their own armbands.
- Stewards will be responsible for finding a dog in the catalog if the exhibitor does not know the armband number. Stewards will not hand their catalogs to exhibitors for review.
- Limited public seating will be provided at designated areas around the ring.
- Private chair use will not be allowed in high traffic areas and will be required to maintain social distancing protocol.
- Public poop scoops will NOT be provided in the ex-pens. Exhibitors will be required to clean up after their own dogs.

2. Exhibitors:

- Exhibitors will be required to maintain the required social distancing from other exhibitors while showing their dogs.
- Exhibitors will be encouraged to bring their own masks, hand sanitizer, pens and armband rubber bands or paperclips. BTCA will provide these items if needed.
- Exhibitors will be encouraged to avoid touching dogs that are not their responsibility.
- Each exhibitor shall know their own armband number before going to the ring.
- Exhibitors will not be allowed to congregate at rings, ring gates, superintendent table or head/trophy/catalog tables.
- Ringside crating area will be available to exhibitors with dogs being currently judged in the ring. Exhibitors must vacate as soon as they are done with showing their dog(s). NO ALL-DAY SET UP ALLOWED.

3. Grooming & Crating:

- The layout of the indoor and grooming areas and spaces will comply with the required social distancing.
- Individual grooming spaces will be marked off with tape on the floor to ensure the required social distancing will be maintained.
- Forced air/high velocity dryers will NOT be allowed in the grooming area (conformation event), nor in the Sonoran rooms (obedience/rally event).

4. Judging, Stewards and Awards:

- Judges and stewards will practice ring awareness and take appropriate measures to maintain required social distancing.
- Armbands will be laid out on the ring steward table for exhibitors to pick up before they enter the ring.
- All classes shall be called in catalog order to provide order and efficiency.
- Judges are to have the exhibitor display the dog's oral exam and may personally examine the dog's mouth ONLY if absolutely necessary.
- Judges shall sanitize their hands after examining each entry.
Re-examining of dogs will be minimized.
- Win ribbons and rosettes will be laid out on the ring steward table for the exhibitors to pick up as they exit the ring.
- Trophy presenters will not be utilized.
- No handshakes will be permitted.
- Equipment used to measure and/or weigh dogs will be sanitized before and after each use

5. Head/Trophy /Catalog Tables:

- The head table, trophy table and catalog table will be combined into one area (head/trophy/catalog) to decrease the number of club officials utilized at this event.
- Six foot taped markers on the floor will be used around the tables to maintain the required social distancing.
- Club officials at the tables will maintain the required social distance while working.
- Trophies will be laid out on the tables for exhibitors to pick up self-serve.

6. Host Clubs

- Clubs hosting dog shows on Monday May 24 & 25, 2021 will be required to operate under this event safety plan, state and city ordinances and CDC guidelines regarding COVID-19.

7. Show Superintendent:

- The superintendent will be required to operate under this event safety plan, state and city ordinances and CDC guidelines regarding COVID-19.
- The superintendent area will be laid out to comply with the required social distancing protocol.

8. Obedience & Rally Competition

- Officials, volunteers, and attendees of the Obedience & Rally Competition will be required to operate under this event safety plan, state and city ordinances and CDC guidelines regarding COVID-19
- Masks are mandatory and should be worn at all time in the Sonoran Room and the hotel premises
- Cones must be used in place of stewards in the Obedience Figure Eight Exercises
- Chairs will be placed for leashes and dumbbells. Chairs will be wiped down between competitors. Stewards will not handle these items.
- Stewards will place Utility scent articles and gloves with tongs.
- Rally maps will be posted in two places away from the rings. Participants should use cell phones to photograph the maps. Maps will be posted well in advance or ring time.
- Competitors are expected to maintain proper social distancing at all times.
- These trials are offered under very unusual circumstances. Those who are unable to wear a mask, or to comply with the special COVID19 requirements should refrain from attending for their own safety and the safety of other participants.

9. Vendors:

- All vendors will be required to operate under this event safety plan, state and city ordinances and CDC guidelines regarding COVID-19.

- Vendor stalls will be limited and laid out to comply with the required social distancing protocol.
- Vendor stalls will be separated from each other by a minimum distance of 6 feet.
- Vendors will be encouraged to provide their own hand sanitizer at their booths.

10. Show Photographs:

- The show photographer will be required to operate under this event safety plan, state and city ordinances and CDC guidelines regarding COVID-19.
- The judge will be standing 6 feet away from the dog handler.
- There will be no shaking of hands.
- Photographer will provide his own hand sanitizer at his booth.

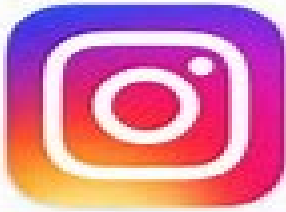
