### DIRECTIONS TO THE SHOW SITE PARKINGLOTS

**From the West:** - From Interstate 10 eastbound, exit at Monroe and go right (south) approximately 4 miles. A map is enclosed and signs will help guide you.

**Handicapped Parking:** From Monroe, turn right into the Tavern parking lot.

**Unloading, Reserved, Officials:** From Monroe, turn right onto Avenue 51

**Day-of-Show Parking:** From Monroe, turn right onto Horse Show Road.

**From the East:** - From Interstate 10 westbound, exit at Monroe, turn left (south), Cross over the freeway and go approximately 4 miles and proceed as above.

### NO SETUPS IN DAY OF SHOW PARKING

Some parking areas may be some distance from your ring(s). An unloading area will be provided. Please follow the instructions of parking attendants. Day-of-Show parking will be \$10.00 per space. Vehicles requiring more than one space (motor homes, etc.) will be parked in the day-of-show overflow parking lot and will be charged \$10.00 per space used. No setups or x-pens will be allowed in day-of-show parking lots. No overnight parking will be allowed in the day of show parking lots. Anyone not following KCPS rules risks having his/her vehicle towed at owners' expense. No abusive behavior will be tolerated. KCPS and Empire Polo Club assume no responsibility for fire, theft or damage to vehicles or cargo, whether legally or illegally parked. Overnight parking is not permitted on the streets in Indio. Valet available beginning on Friday.

**Towing Policy:** Cars parked in the unloading zone will be towed without any public announcement. The towing fee will be \$200.00, plus the \$10 day-of-show parking fee.
