**RAMP** - At the discretion of the judge, the following breeds may be judged on a ramp: Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Norwegian Buhund, Portuguese Podengo Pequeno, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Chinese Shar-Pei, Chow Chows, Keeshonden, and Polish Lowland Sheepdogs. Whippets may be judged on the ground, table or ramp. Basset Hounds and Bulldogs are expected to be judged on a ramp. Boykin Spaniels may be judged on a ramp or table. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp breeds. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. The 5<sup>th</sup> Annual Breeders' Showcase-2013 is a Special Attraction event offered within an AKC Sanctioned All-Breed Dog Show and Obedience Trial.

### **Entries:**

- The Breeders' Showcase-2013 will start at group level
- Each entry shall consist of two dogs of the same breed or variety. They may be either male or female or one of each

- All cash prizes will be awarded on Saturday, August 24, 2013 and the check will be made out to the common breeder.

# 2013 Judges' Biographies

Bo Bengtson – Beginning in Sweden in 1959 and since 1980 in the United States, has bred and exhibited Whippets. He has also, to a lesser degree, been involved in Greyhounds and Afghans. He was approved to judge all Sighthound breeds by the FCI in 1976 and is currently approved to judge 32 breeds in 5 different groups under that system. He is the editor of several dog books, including the award winning *Best In Show; The World of Show Dogs and Dog Shows and The Whippet*. He was publisher and editor of the *Sighthound Review* from 1984 to 1997, is past editor of *The Afghan Hound Review* and of *Poodle Variety*. In 1997 he founded, in partnership with Paul Lepiane, the monthly *Dogs In Review* which was sold in 2001 to Bow Tie, Inc. but to which he still contributes.

Judy Bennett – Judy and her husband Dean acquired their Samoyeds in 1973 and both achieved their CD Titles. Her original conformation Samoyeds were from early Polar Mist line. Judy produced Group Winners and placers, both in the United States and internationally. Her dogs have taught her so much and gave her a passion for soundness, movement, beauty and the amazing temperament of the Samoyed. Judy began judging in 1992, and is now approved to judge Siberian Huskies, Pembroke Welsh Corgis, Australian Shepherds and Junior Showmanship. Protecting the soundness and breed type of these breeds has become one of her highest goals. Passing on this deep love and appreciation for dogs to our next generation is an upmost priority. Judy feels we have a short window of opportunity to gently mold our youth into competition of tomorrow and to become heirs of our dreams.

Mary Anne Brocious – Mary Anne is a breeder of Old English Sheepdogs and has bred and/or owned over 100 AKC Champions under the kennel name Qubic. Her OES have achieved Best in Shows, Best in Specialty Shows and multiple group wins with dogs competing successfully in Obedience and Agility also. She has bred multiple Register of Merit Dogs and Bitches and top producing sires and dams including the only Top 20 winner to produce a Top 20 winner in breed history. Mary Anne is Chair of Judges Education for the Old English Sheepdog Club of America and Show Chair for the Ann Arbor Kennel Club where she also has served as their AKC delegate. She judges the Herding and Working Groups and has had the privilege to judge in Australia, China, Taiwan, Mexico and several European countries.

Connie Clark – Connie, a member of the Santa Barbara Kennel Club, began exhibiting and breeding Wire Fox Terriers in 1977. In the early 1980s, she apprenticed with Clay and Bergit Coady and in 1985 began handling professionally, specializing in the hard-coated Terriers. In 2000 she moved from Illinois to California and retired from handling. Connie began judging in 2007.

Nioma Stoner Coen – The first litter of Macdega Shelties was whelped in 1964. All of their dogs trace many times to their pillar sire BIS Ch. Halstor's Peter Pumpkin ROM, the breed's top sire with 160 American champions. Nioma and her husband feel fortunate to have been owned by so many special Shelties who have contributed to their breed. In 2005, they were honored by the American Kennel Club as breeders of the Year for the Herding Group. Since receiving her judge's license, Nioma has had the pleasure of evaluating the efforts of breeders in the U.S., Canada, Denmark, Japan and China.

Thomas W. Coen – The first litter of Macdega Shelties was whelped in 1964. All of their dogs trace many times to their pillar sire BIS Ch. Halstor's Peter Pumpkin ROM, the breed's top sire with 160 American champions. Thomas and his wife feel fortunate to have been owned by so many special Shelties who have contributed to their breed. In 2005, they were honored by the American Kennel Club as breeders of the Year for the Herding Group. Tom has also judged in Canada, Denmark, Japan and China. Thomas continues to actively breed and show Macdega Shelties.

Larry Cornelius – Larry is a professional handler living in Florida. He and his partner, Marcelo Veras, show all breeds. Larry grew up in Minnesota where his parents bred Dobermans. He started showing as a junior and apprenticed with Bryan and Nancy Martin and Peter Green before he became a professional handler in his own right. In 2004 he had the #1 Non-Sporting dog with French Bulldog, Ch. Bandog Jump For Joy. Then in 2007 he won Crufts with the Tibetan Terrier, Araki Fabulous Willie. He was voted *Dogs In Review* best professional handler in 2009. In 2011 he won Showdog of the Year for the Terrier Group with a Skye Terrier who became the top winning Skye in Breed History. He is a member of The AKC Registered Handlers Program and also The Professional Handlers Association.

Betsy Dale – Betsy, a member of the Santa Barbara Kennel Club, began judging in 1984. Before that, she spent 20 years breeding and exhibiting Airedales. Since that time she has also been involved with Welch Terriers, Scottish Terriers and Brussels Griffons. She is approved to judge all Terriers, Non-Sporting and Toy Breeds.

Pamela A. Davis – Pam is a life time dog lover and also a member of the Santa Barbara Kennel Club. She received her first Cairn Terrier as a gift from her husband, Chris in 1984. She was a wonderful addition to their family, and soon after she moved in Pam became interested in exhibiting and breeding Cairns. She has bred and owned the #1 Cairn in the U.S. for 7 of the past 10 years including the #1 Cairn in breed points ever, GCH. Dogwood Love Affair, call name Romeo. Pam became interested in judging her breed several years ago and is delighted that the Santa Barbara Kennel Club has invited her to judge at our show.

JoAnn K. Dutton – JoAnn's life in purebred dogs started with an American Staffordshire Bull Terrier and Toy Poodle, however, it was a Miniature Schnauzer that propelled her into the dog show world. Wire Fox Terriers came next, then a Giant Schnauzer. In searching for a breed that required a little less grooming, JoAnn later had a white Bull Terrier that joined her home. In 1983 JoAnn began judging; she has judged all over the United States, Canada, Australia, China, Africa and Taiwan. After all these years, JoAnn still deeply enjoys judging dogs.

David C. Fitzpatrick - David is a Professional Handler of Toy breeds and some Non-Sporting breeds. He began his life in dogs working for dog handlers in 1970 and now resides in Pennsylvania. He is best known for his top winning Pekingese and has finished hundreds of dogs for clients around the world. His charges have been awarded number one Toy Dog seven times. He has won the group at the Garden several times and in 2005 Ch. Yakee If Only was also the number one dog all breeds and broke the previous record for Pekingese by winning 128 Bests in Shows. GCh Palacegarden Malachy won the group at the Garden in 2011 and in 2012 he was awarded Best In Show at Westminster finishing his career with 115 Bests. In 2006 David was awarded the *Dogs In Review* Best Professional Handler, and in 2009, the Toy Group Breeder of the Year awarded by the American Kennel Club.

Geir Flyckt-Pedersen – Geir has been involved with the dog world since the mid 1950s. He was born in Norway, but has lived most of his life in England and Sweden. He currently resides in the United States. He began in Obedience with German Shepherd Dogs and a Boxer. He has successfully bred and showed Wire Fox, Airedales, Norfolk and Welsh Terriers. He has owned or handled champions in other terrier breeds including Lakeland and Kerry Blue Terriers as well as the Schnauzer, Springer Spaniels, and English Setters. He was first in history to win Dog of the Year in both Norway and Sweden the same year, and did it twice – the record still stands. Along with his wife, Geir was awarded Tom Horners Award of Excellence for their contributions to the British Dog Scene. He is approved to judge all breeds and Bests In Show in the U.K.

Lynda Gall - Lynda and her husband Robert have been breeding and showing English Setters and English Cockers since 1978. Their dogs have won many awards both on a local level and a national level. In 1995 their dream came true when their Ch. Lynann's Telesis won the English Cocker National, handled, as always, by Lynda. Again in 2003 they won the National with Ch. Lynann's Timeless Imager which was their second generation of National Specialties winners. They are active in animal rescue with both breeds. They have been members of the English Cocker Spaniel Club of America for 25 years.

Susan Hamil - Susan got into dogs in the 1960s while showing Quarter Horses. Her first AKC registered Bloodhound came in 1966 and she has since bred and/or finished over 60 champions. The Quiet Creek dogs have won several Nationals and won the Hound Group at Westminster in 2001 with Ch. Ridgrunner Unforgettable (a stud fee puppy) who is the top winning Bloodhound bitch of all time. She has been a member of The American Bloodhound Club since 1970 and served as their delegate for almost 10 years. She has judged the parent club national, as well shows in England, Italy, Finland and France. She also serves as a director of the AKC Canine Health Foundation and the Orthopedic Foundation for Animals.

Sylvia Hammarstrom – Sylvia bred her first Schnauzer Champion in Sweden in 1949, so 2013 is her 64th year in dogs. In those years she has bred over 1,000 Giant Schnauzer Champions, many having won Best s In Show all over the world, at least 500 times. Most of her dogs are family members, guarding adults and children, but many are active working dogs for police, customs, guide dogs etc. Twenty-five years ago she published the first book in the English language about the Giant Schnauzer, *The Giant Schnauzer in America*. Sylvia has also bred champions in the following breeds: Standard and Miniature Schnauzers, Bouvier des Flanders,

Rottweilers, Greyhounds and Silky Terriers. She has judged in over 12 countries and in 2004 judged the Giant and Standard Schnauzers at Crufts.

Lauren Hay-Lavitt – In her years of Junior Showmanship Lauren was #1 Std Schnauzer Junior in 2006, #1 Pointer Junior in 2007 and #1 German Shorthaired Pointer Junior in 2008. Lauren was awarded Best Jr. Handler at the Westminster Kennel Club in 2008 showing a GSP at the age of 14. She has been assistant to professional handler Valerie Nunes-Atkinson for 9 years and plans to pursue a career as a professional handler when she graduates from college.

Jean Hetherington – Along with her husband, Bob, Jean has been breeding Bulldogs since 1964 using the prefix, Hetherbull. Hetherbull has had over 100 Bulldog champions, including multiple Best In Show, National Best of Breed, Group and Specialty winners. One of the dogs from their first litter won the 1966 Bulldog Club of America National Specialty. Jean was *Kennel Review* owner-handler of the year in 1989. Other breeds that Jean is involved in are Chow Chows, Brussels Griffons, French Bulldogs, Pomeranians, Wirehaired Dachshunds and Airedale Terriers.

Jamie Hubbard – Jamie, a member of the Santa Barbara Kennel Club, has a long history in purebred dogs that spans the globe. Born in Adelaide Australia, his family bred and showed Basset Hounds. Over the next twenty years, he has had considerable success as a breeder and owner of both American Cocker Spaniels and English Setters, including Best In Show wins at both the Sydney Royal Show and the Melbourne Royal Show, which is the largest show in the Southern Hemisphere. Jamie moved to the United States in 2005 and along with his partner breeds Clumber Spaniels and Welsh Springer Spaniels under the Clussex prefix. He began judging in Australia at the age of 18 and there was approved to judge the Sporting, Hound and Herding groups before his moving to the United States.

Elizabeth C. Hugo-Milam – Elizabeth is a lifelong breeder/owner and handler of National Specialty, Group Winning and Specialty winning Bulldogs. She has been active in Bulldog Club of America's judge's education since 1990 and has presented seminars on the breed and its history with clubs and judges groups all over the U.S. and abroad. Elizabeth currently serves as head of the BCA Health Committee. She is also a BCA Hall of Fame Breeder and an AKC Breeder of Merit. She has judged Bulldogs since 1993 and French Bulldogs since 2011. She has owned French Bulldogs since the mid 1980s. She and her husband Jack raise Bulldogs and Arabian horses. They also are proudly owned by a few stray dogs, a lovely Whippet, a beautiful Golden Retriever and a very ornery Zebra named "Stripes".

Mark Houston-McMillan – Mark has been breeding and showing Shetland Sheepdogs and Dachshunds for more than 25 years under the GrandGables kennel name. His achievements in Shetland Sheepdogs and Dachshunds include the breeding of National and Specialty winners - Westminster, Crufts & World Show winners and All Breed Best in Show winners in several countries. Some of the other breeds he has owned include a German Shepherd, Boston Terrier, Fox Terrier, Brussels Griffon and a Chinese Crested. Mark started his judging career in South Africa and currently judge all breeds in Canada. He has had the fortune to judge the U.S. Miniature Dachshund National and look forward to judging the U.S. Shetland Sheepdog National in 2014. Besides judging in Canada and the US, he has also judged in Australia, Brazil, Finland, Iceland, Japan, Russia, Switzerland, South Africa and UK.

Guy Jeavons – Guy Jeavons was born in old colonial Rhodesia, now Zimbabwe, into a family owned by Dachshunds. The GrandGables Kennel was registered in Canada in 1972 when Guy acquired his first Shetland Sheepdog, hence the involvement along with his partner Mark Houston-McMillan in both Dachshunds and Shelties. He first was licensed as an all-breed judge with Kennel Union of South Africa and is now licensed as an all-breed judge in Canada. He has had the privilege to judge throughout the world. He had the honor to be voted as BOB judge for the 2009 ASSA National in the US and has also judged Dachshund Club of America National in 2001 as well as many other shows in the US. He immigrated to Canada in 1998 and the GrandGables Shelties and Dachshunds have won numerous BIS and BISS as well as, group placements at both Crufts and Westminster.

Mareth K. Kipp – After a dogless childhood, Mareth was lucky enough to obtain her first Airedale after her marriage. Mareth and her husband are dairy farmers in Wisconsin and were looking for an all around dog that could be defender of their children, a good cow dog, and a dog that would hunt when called upon. This lead to

an interest in finding a show dog, they purchased their foundation bitch over 45 years ago. Every dog she has bred since goes back to that same bitch. They have bred almost 80 Champions, including National Specialty, Regional Specialty and Best In Show winners. Mareth currently judges the Terrier and Sporting Group and some working breeds. She has judged all over the world and is the Show Chair for Waukesha Kennel Club.

Glen Lajeski – Glen, a member of the Santa Barbara Kennel Club, grew up with Miniature Pinschers and in college decided that he needed a larger dog which resulted in the acquisition of a Great Dane. After breeding and finishing Danes in order to pay for his higher education, he began handling professionally. Later, when Bud Dickey decided that Glenn needed to learn how to groom dogs, Bud presented him with his first Standard Poodle which he handled to her championship, eventually leading to a lifetime in Standards. He is still involved in Poodles and judges breeds in the Non-Sporting, Working and Toy Groups.

Richard Meen, M.D. – Dick, a member of the Santa Barbara Kennel Club, became actively involved in purebred dogs in 1965 with the purchase of his first Afghan Hound. He then went on to breed and exhibit Borzoi, Skye Terriers, Harriers, Italian Greyhounds, French Bulldogs, Old English Sheepdogs, Scottish Deerhounds and Doberman Pinschers. He is a past President of the Canadian Kennel Club and is approved in Canada to judge five groups.

John Reeve-Newson – John, a member of the Santa Barbara Kennel Club, has been a practicing veterinarian since 1964 and has practiced in both the United States and Canada. He founded the first emergency animal clinic in Canada. He along with Dr. Richard Meen established Kishniga Kennels in 1971. They have bred Group and Best in Show winning Dobermans, Old English Sheepdogs, Skye Terriers, French Bulldogs, Borzoi, and Harriers. They have also owned and exhibited Group and BIS winning Lakeland Terriers, Norwich Terriers, Standard Poodles, Scottish Deerhounds, American Foxhounds and Whippets. John is approved to judge all breeds.

Alan C. Santos – Alan started in Cocker Spaniels in 1965 while he was in high school, he was working as Bill Ernst's show assistant then, He took a temporary "leave of absence" from dog shows to attend college and post graduate training. He returned to Cockers in 1998 with the purchase of a tri colored Cocker. Since then he has bred several litters and is still active in exhibiting.

Augusto Benedicto Santos III – More familiarly known as "Dinky", Senior Santos was born into a family of animal lovers. Together with his family he was involved from an early age with showing German Shorthaired Pointers, Japanese Akita Inus, Bull Terriers and German Shepherd Dogs before getting engrossed with Labrador Retrievers. He is presently involved with German Shepherd Dogs that he has shown both in Germany and the Philippines. Dinky has also very much involved with horses. He was a member of the Philippine Equestrian Team. Dinky is currently the President and Chairman of the Philippine Canine Club.

Luis Pinto Teixeira (Portugal) – Luis has owned, exhibited and breed German Shepherds, Irish Setters, Boxers, Dachshunds, Cocker Spaniels and Golden Retrievers. Luis has ben recognized by the Portuguese Kennel Club and FCI since 1975, and became an all rounder in 1985. He has judged on five continents, and in 75 counties.

Marcelo Veras - Marcelo is from Brazil. He has had Dobermans all of his life and also has bred some Siberians in his late teens which channeled him into showing dogs. For 7 years, as professionals, he partnered with Marcelo Chagas in Sao Paulo, where they showed as well in the United States and Europe. Marcelo moved to Florida in 2002. He and his partner Larry Cornelius are professional handlers of all breeds. They are very proud to have achieved some great records on dogs in all groups. He is a member of The AKC Registered Handlers Program and also The Professional Handlers Association.

**Novice Junior Class:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Novice Intermediate Class:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Novice Senior Class:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Junior Class:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Intermediate Class:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Senior Class:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Master Class:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 – October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Each dog handled in a Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, another dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future Showmanship Classes which have been approved to date by AKC online at [www.akc.org](http://www.akc.org)

Junior Handler's must include their AKC Junior Handler identification number on the entry blank.

## ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw, 5434 East Olympic Boulevard, Los Angeles CA, 90022, by Noon, Wednesday August 7, 2013 PDT. Fees should accompany entries. This club and/or its superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7 a.m. to 11:30 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available at [www.akc.org](http://www.akc.org).
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. 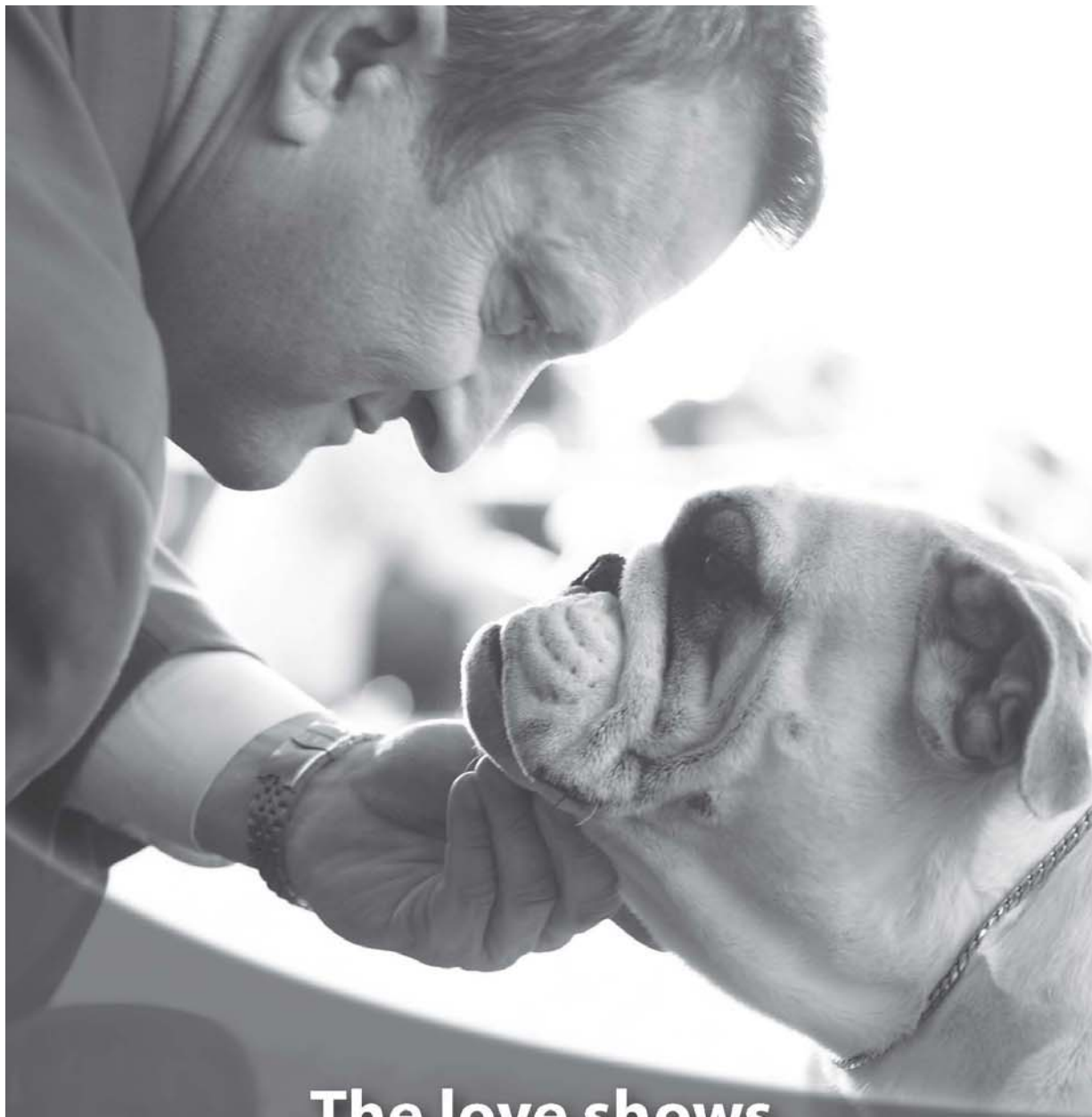

## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All-American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
