



#### **NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES**

Veteran (divided by sex): 7 and under 10 years (4/19/03 – 4/18/06); 10 years and older (Any dog born before 4/18/03)

*Entrants in the Veteran Classes need not be intact. Spayed and neutered animals are eligible.*

Working (divided by sex): A class for Dogs and a class for Bitches with working/performance titles. The Dog/Bitch must have earned one or more of the following AKC titles: CD; RN; TD; HS; NA; NAJ; NAP; NJP; NF; NFP; or an American Rottweiler Club CS. A Dog/Bitch is also eligible if it has earned one of the following titles: SchH A; SchH I; IPO I; VPG I; FH; BH; AD. Copy of title and/or Scorebook must be included with entry. Spayed and neutered animals are ineligible to be entered in this class. Champions of Record are eligible to enter. Winners of the Veterans and Working classes, if otherwise undefeated, are eligible to compete for Best of Breed.

#### **BEST OF BREED (VARIETY) COMPETITION**

**Best of Breed (Variety) Competition** - "The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

**ARC SELECT AWARDS:** All dogs eligible for the Best of Breed Competition shall be considered for these awards. At the discretion of the Intersex judge, the maximum number of Select Awards that may be given shall be 10% of the Best of Breed entry, including Veterans, Winners and Working Dog/Bitch. That 10%, with no consideration to sex, is in addition to the ones automatically given Best of Breed and Best of Opposite Sex to Best of Breed winners and the AKC Grand Championship Select Dog and Bitch (if awarded). The Best of Breed and Best of Opposite Sex to Best of Breed shall be known as ARC Select 1; the AKC Grand Championship Select Dog and Bitch shall be known as ARC Select 2; all others chosen shall be known simply as ARC Select.

**BEST PUPPY FROM THE REGULAR PUPPY CLASSES AND BEST FROM THE BRED BY EXHIBITOR CLASSES:** Winners of Best Puppy or Best Bred by Exhibitor are not, by right of winning this award, eligible to compete for Best of Breed.

#### **Non-Regular Classes Involving Multiple Dog Entries**

The judge's decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible for Best of Breed Competition by virtue of having won any of these classes.

**STUD DOG CLASS** – For Stud Dogs and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the stud dog need not necessarily be owner of the get. While the merits of the stud dog are not to be considered in the placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a regular class, Best of Breed Competition, or some other Non-Regular class.

**BROOD BITCH CLASS** – Same as above except substitute Brood Bitch for Stud Dog and Produce for Get.

THE FUTURITY IS OPEN TO ALL BREEDERS OF LITTERS ELIGIBLE TO BE REGISTERED WITH THE AMERICAN KENNEL CLUB. HOWEVER, LITTERS MUST MEET ALL THE REQUIREMENTS OF THE ARC MANDATORY PRACTICES\*\* IN EFFECT AT THE TIME OF THE BREEDING. IF IT IS LATER DETERMINED THAT THE BREEDING DID NOT COMPLY WITH THE ARC MANDATORY PRACTICES, ALL NOMINATION FEES, LITTER AND PUPPY, WILL BE FORFEITED. (\*\*ARC Mandatory Practices may be found on [www.amrottclub.org](http://www.amrottclub.org) or available from the ARC Futurity Chairman.)

Any breeder of a nominated litter who fails to remain in good standing with the American Kennel Club and has not been reinstated 60 days prior to the Futurity shall lose all rights in the ARC Futurity. There will be no refunds of any nomination fees - litter or puppy.

The Futurity is entered by nominating the litter. The get from this litter are eligible to compete in the first annual Futurity held on or after the date they reach 6 months of age, and only in this Futurity.

The Futurity is open to all Rottweilers who were born between 11/23/11 and 10/17/12, provided both the litter and the individual puppy have been properly and timely nominated.\* The puppy MUST be entered in one (1) of the regular classes at the ARC National Specialty show and entry fee paid. Futurity entry MUST BE INDICATED AS AN ADDITIONAL CLASS on the entry form, even though no additional fee is required. Additional class entry must include age division (e.g., futurity 6-9 months).

No Rottweiler will be eligible to compete in the Futurity that does not meet the following requirements:

1. Be from a litter that was properly and timely nominated, or have met the requirements for late nomination.
2. Have been individually nominated before it reached the age of 4 months, or have met the requirements for late nomination.
3. Be properly entered in one (1) of the regular classes of the ARC National Specialty.
4. Both parents of the litter must meet all the requirements of the ARC Mandatory Practices for Breeding.

\* The dates of the ARC National Specialty fluctuate from year to year. Puppies are eligible to compete in the first ARC National Futurity held on or after the date they reach six months of age, and only in this Futurity. The Futurity was held in 2012 on May 22nd, so dogs born between 10/17/11 and 11/22/11 are ineligible to compete even though they are under 18 months of age.

## **FUTURITY PRIZES**

In this stake there will be thirty-five (35) cash wins, the three individuals (the breeder, the owner, and the owner of the sire at the time of nomination) partaking of these awards, for a total of seventy-two (72) monetary awards, won by thirty-two (32) different Rottweilers.

Twenty percent (20%) shall be deducted from the total nomination fee purse to be used for Futurity expenses. This will be known as the General Expense Fund. This Fund shall be used to cover all expenses incurred by the Futurity, i.e., judges, rosettes, Chair expenses, etc. Since the administrative and judging expense will vary from year to year, excess in any given year shall be carried for use in future years.

Twenty percent (20%) shall be deducted from the total nomination and entry fee purse to be awarded as follows: 10% to the Best in Futurity, 5% to the Best Senior in Futurity, and 5% to the Best Junior in Futurity. The 10% Best in Futurity award will be divided: 50% to the recorded breeder of the winner and 50% to the recorded owner of the winner. The 5% awarded to the Best Junior and Best Senior in Futurity is to be divided: 50% to the recorded breeder, 30% to the recorded owner and 20% to the owner of the sire or owner of the frozen semen at the time of mating, for each winner.

The remaining 60 percent (60%) of the total nomination fee purse shall be divided using the following procedure. As soon as possible after closing, the Show Superintendent/Secretary will inform the Futurity Chairman of the total number of puppies entered in the Futurity, as well as the breakdown of each class. The prize money will be divided by the total number of puppies entered to get a "per puppy amount". This amount would be multiplied by the number of puppies in each class to get the total amount of prize money for that class and then each class shall be divided as follows: 1<sup>st</sup> place – 40%\*; 2<sup>nd</sup> place – 30%\*; 3<sup>rd</sup> place – 20%\*; 4<sup>th</sup> place – 10%\*. Should the entry in a particular class be less than 4, prize money will be calculated as follows: 1 entry: 1<sup>st</sup> place – 100%\*; 2 entries: 1<sup>st</sup> place - 57%\*; 2<sup>nd</sup> place - 43%\*; 3 entries: 1<sup>st</sup> place - 45 %\*; 2<sup>nd</sup> place - 33%\*; 3<sup>rd</sup> place - 22%\*. (\* The prize money for each placement shall be further divided with 60% to the recorded breeder; 40% to the recorded owner.)

Monetary Awards will be given to the handler presenting the puppy in the ring for the four class placements. The Best Junior, Best Senior and Best in Futurity monetary awards will be given to the breeder who nominated the litter, the sire's owner who is listed first on the litter nomination and the puppy owner who is listed first on the individual puppy nomination. The monetary award will be mailed to them should they not be present.

Monetary awards, which are provided for but cannot be given, whatever the reason, shall be sent to the ARC Treasurer and incorporated into the ARC General Fund.

The Best in Futurity Trophy will be given to the breeder who has nominated the litter. Should the winner not be present the trophy will be mailed.

This club and/or its superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. 7.
