Boykin Spaniels Whippets may be judged on the ground, table or ramp. Basset Hounds and Bulldogs are expected to be judged on a ramp. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp breeds. Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.) 7/8/13

### BEST OF BREED (VARIETY) COMPETITION

**Best of Breed (Variety) Competition** - "The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

## **SATURDAY BEST PUPPY COMPETITION**

There will be a Best Puppy Competition. Competition will be for Best of Breed or Variety Puppy, Best Puppy in Group (placements 1 through 4) and Best Puppy in Show.

### **RULES:**

During the course of regular breed judging, the assigned judge will select a Best Puppy from the class winners of the six to nine month and nine to twelve month classes. This will be done after Best of Breed judging unless the Best Puppy award is automatic. Example: An entry from the puppy classes is awarded Best of Winners or Best of Breed. Only dogs or bitches undefeated in a puppy class are eligible for Best Puppy Competition. If the first place winner is not present the second place winner **may not compete**.

All Best Puppies will compete in their respective Best Puppy Groups. All Best in Group puppies will compete for Best Puppy in Show.

THERE WILL BE NO ADDITIONAL ENTRY FEE FOR THIS COMPETITION. PUPPIES MUST BE ENTERED IN THE REGULAR 6 TO 9 MONTH OR 9 TO 12 MONTH PUPPY CLASS TO BE ELIGIBLE FOR THE BEST PUPPY COMPETITION.

Any arguments, abusive language, or failure to follow the rules and/or instructions of parking officials and/or Club officials may cause withdrawal of privileges and possible discipline by the Show Committee.
13. NO OUTSIDE FOOD AND/OR BEVERAGES ARE ALLOWED INSIDE THE CONFERENCE CENTER. Food and/or beverages purchased from the hotel can be brought into the Conference Center during the show.
14. NO GROOMING is allowed in the conference/convention center. There will be designated crating areas in the conference center. No x-pens allowed in the conference center.
15. PLEASE RESTRAIN YOUR DOGS FROM URINATING AND/OR DEFECATING INSIDE THE CONFERENCE CENTER. A \$200.00 CLEANING FEE MAY BE IMPOSED TO REPEAT OFFENDERS (not necessarily the same dog but the same EXHIBITOR). A Bench Show Committee will result if there is a flagrant disregard of using the indoor show venue as a relieving area for your dogs.
16. Crating is permitted prior to and during breed judging. All crates must be moved to a designated area within the conference center upon completion of that breed judging or a \$25.00 fee will be charged by the show for removing and storing. CRATES WILL BE ALLOWED OVERNIGHT IN THE CONFERENCE CENTER IN DESIGNATED AREAS.
17. Please plan to have one crate per dog exhibited. Do not house multiple dogs in one crate.
18. Any owners/handlers leaving dogs ringside unattended before or after scheduled time for that breed may be subjected to a show committee hearing.
19. Any owners/handlers leaving dogs unattended in any parked vehicle may be in violation of county ordinances pertaining to animal cruelty. At such time an animal is discovered to be locked in a hot temperature vehicle, any manner used to free the animal will **not** result in liability to BMKC, it's members, or Palace Station. Please take action and plan accordingly for all possible weather conditions. ## ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw, 5434 East Olympic Boulevard, Los Angeles CA, 90022, by Noon, Wednesday, September 25, 2013 PDT. Fees should accompany entries. This club and/or its superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card must be made good by cash or money order before the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed. The club reserves the right to substitute a prize of equal or greater value.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at [www.akc.org](http://www.akc.org).
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises and further assume no responsibility for injury to children, and or spectators.
8. No grooming tables, pens or exhibitors setups will be allowed in the aisles. All tables, pens or exhibitor setups must be at least 10 feet away from the judging rings in areas specified by the club.
9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$2.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at these show and may be told to be removed by the show committee.
11. Declination of Entries. The Black Mountain Kennel Club of Nevada may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half hour prior to the start of the earliest Conformation judging at the Show.
16. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
17. Unscheduled practice is not allowed in rings at any time.
