**BEST OF VARIETY COMPETITION**

**Best of Variety Competition** - "The following categories of dogs may be entered and shown in Best of Variety competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

Stud Dog and/or Brood Bitch are not offered.

**PUPPY SWEEPSTAKES**

1. All puppies entered in the Puppy Sweepstakes must be eligible for and entered in the Regular Classes at this show.
2. To stimulate interest in showing promising purebred Cocker Spaniel puppies, a Puppy Sweepstakes shall be held in conjunction with and as a special class of at the Cocker Spaniel Club of San Diego Specialty Show. The Puppy Sweepstakes is not limited to members of the Club, but is open to all exhibitors of purebred Cocker Spaniels.
3. Puppies shall be divided in age groups of 6 to 9 months, and 9 to 12 months, divided by sex and variety.
4. Entry fees for the Puppy Sweepstakes shall be set by the Club and entry monies received shall be distributed as follows, after the club has deducted 30% to defray expenses: Best in Sweepstakes – 25%; Best of Opposite Sex to Best in Sweepstakes –15%; Best of Variety in Sweepstakes – 10%. If any prize monies are not awarded for any reason, they shall revert to the club.
5. The entry for each puppy entered in the Puppy Sweepstakes must accompany the regular class entry, stating "Puppy Sweepstakes" and stating variety, sex, age and class division in the Additional Class space on the regular entry form.

**VETERAN SWEEPSTAKES**

The Veteran Sweepstakes is open to all Cocker Spaniels which are 7 years and older on the day of the show. All varieties will be shown together, divided by sex, and age: 7 and under 10 years; 10 years and older. Dogs entered in Veteran Sweepstakes need not be entered in a Regular Class. All fees for the Veteran Sweepstakes will be distributed: 30% to the Cocker Spaniel of San Diego (to defray expenses); 25% Best in Sweepstakes and 15% Best of Opposite Sex to Best in Sweepstakes, 10% Best of Variety in Sweepstakes.

If advanced payment for privileged parking is not paid by February 6, 2013, no guarantee of parking in preferred area can be made. If paid at gate on night before show, charge is \$40.00 per night, with no guarantee parking.

**REQUIREMENT** - All units must be self contained, no water.

**ELECTRICITY** – Because of rising costs, electricity will be very limited in the three show buildings. It will not be available anywhere outside, except for motor homes.

Security guards on duty. No holding of parking space for others.

Exhibitors will be held responsible for clean conditions in and around their motor homes, both during and after the show. Waste water may not be emptied on the grounds or drained into open containers.

Any unnecessary argument or abusive language will cause forfeiture of parking privileges, without a refund.

### ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw, 5434 East Olympic Boulevard, Los Angeles CA, 90022, by Noon, Wednesday February 6, 2013 PDT. Fees should accompany entries. This club and/or its superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7 a.m. to 6:00 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at [www.akc.org](http://www.akc.org)
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club.
9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$2.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at this show.
11. Declination of Entries. The Cocker Spaniel Club of San Diego may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. A Recording Fee of 50 cents and an Event Services Fee of \$3.00 will be required at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These fees are to be collected by the Show-giving Club and paid to the American Kennel Club.
15. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half hour prior to the start of the earliest Conformation judging at the Show.
16. Parents and/or guardians are responsible for the actions of their children.

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
