NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

Veteran Dogs and Bitches - For dogs and bitches 7 years of age and older

BEST OF VARIETY COMPETITION

Best of Variety Competition - "The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES

Stud Dog Class - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

Brace Class - For two Poodles with one common owner. Both must also be entered in a regular class at this show.

SPECIAL NON-REGULAR CLASSES

Best in the Puppy Class - Following each Best of Variety Competition, the First Place Winners of the four Puppy Classes shall compete for the Title of Best of Variety Puppy. Following Best of Breed Competition, the three Best of Variety puppies shall compete for Best Puppy in Show.

Best in the Bred by Exhibitor Classes - Following each Best of Variety Competition, the two First Place Winners of the Bred by Exhibitor Classes shall compete for the Title of Best of Variety Bred by Exhibitor. Following Best of Breed Competition, the three Best of Variety Bred by Exhibitor winners shall compete for Best Bred by Exhibitor in Show.

Best in the Veteran Classes, Best Stud Dog, Best Brood Bitch - Following each Best of Variety Competition, the two Veteran shall compete for the Title of Best of Variety Veteran. Following Best of Breed Competition, the three Best of Variety Veteran, Best of Variety Stud Dogs, and Best of Variety Brood Bitches shall compete respectively for the Title of Best Veteran, Best Stud Dog and Best Brood Bitch in Show.

- 1. Entries must reach the Superintendent, Jack Bradshaw, 5434 East Olympic Boulevard, Los Angeles CA, 90022, by Noon, WEDNESDAY JUNE 19, 2013 PDT. Fees should accompany entries. This club and/or its superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
- 2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
- 3. Exhibitors' identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
- 4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly, in order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club nor of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7 a.m. to 8 p.m.
- 5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the Superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
- 6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are online at www.akc.org.
- 7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care, custody and control of its owner or handler during the entire time the dog is on the show premises.
- 8. No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club.
- 9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$2.00 fee charged for cancellation of entry prior to closing of entries.
- 10. There is no provision offered for unentered dogs at this show.
- 11. Declination of Entries. The Poodle Club of Southern California may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
- 12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
- 13. Do not leave any dogs in closed vehicles.
- 14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one half hour prior to the start of the earliest Conformation judging at the Show.

PARKING

Please allow adequate time to get to your ring for judging in the event of parking congestion.

DAY OF SHOW PARKING. Seaside Park will collect a fee of \$5.00 per day at the entrance. Parking is permitted only in assigned lots and is prohibited in fire lanes. No day of show parking in overnight parking areas. Valet parking will be available at the Main entrance to the Fairgrounds.

ALL HANDICAPPED PARKING is in official, painted spaces located in the paved lot in front of the walk-in Fairgrounds entrance.

UNLOADING ZONES are located behind San Miguel and Anacapa Halls and by Santa Cruz Hall. You must leave the lights on during unloading. You may have to transport your dogs and equipment as far as 100 yards from the unloading zone to your ring area.

Following unloading, cars must park in the unpaved lot on the far side of the overnight parking.

OVERNIGHT PARKING. OVERNIGHT PARKING WILL BE LIMITED TO THE FIRST 300 SPACE

RESERVATIONS. Those wishing to park together should send reservations in the same envelope. All spaces are 22 feet wide and 40 feet long. Any RVs over 40 feet long must purchase two spaces. All tag vehicles will be charged \$5.00 per day. Discharge of grey water or sanitary waste anywhere on the Fairgrounds is strictly prohibited. All RVs must have a working fire extinguisher.

Dogs are not allowed outside overnight. All generators must be off between 10:00 pm and 6:00 am.

Grounds are NOT available for set-ups on Wednesday

EXCEPT Specialty Exhibitors for the Thursday Specialty Shows listed above, Obedience Exhibitors, and Vendors, who may begin set-up after 3:00 p.m. on Wednesday.

GATE 1 will be open Wednesday at 3:00 pm and close at 11:00 pm. Gate 1 will open at 6:00 am Thursday and will close at 11:00 pm. Friday and Saturday it will be open from 6:00 a.m. to 8:00 a.m. and will re-open one hour after Best in Show until 10:00 p.m. There will be no RV parking on Sunday.

<u>UNRESERVED OVERNIGHT PARKING</u>. If available, unreserved parking will be on a first come and cash only basis. Parking will be in the large lot by the front gate. All fees will be collected at the gate. Unreserved Fees are:

ELECTRICAL HOOKUPS. RV electrical hookups will be available in overnight parking areas only. Electrical hookups to the buildings will not be allowed.

The cost for a 30 AMP RV connection is \$50.00 per day with a minimum of 3 days, Friday through Sunday. Electrical power for a fourth day, Thursday, is available for an additional \$50. - 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
