RAMP - At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: Lagotto Romagnolo, Nova Scotia Duck Tolling Retriever, American Water Spaniel, Boykin Spaniels, English Springer Spaniel, Field Spaniel, Welsh Springer Spaniel, Grand Basset Griffon Vendeen, Whippet, German Pinscher, Standard Schnauzer, American Staffordshire Terrier, Irish Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terrier, Finnish Spitz, Australian Cattle Dogs, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdog, Mudi, Norwegian Buhund, Polish Lowland Sheepdog, Puli, Spanish Water Dog, Norrbottenspet, Mudi.

The following breeds may be judged on the ground, table or ramp: Miniature Bull Terrier.

The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniel, Sussex Spaniel, Basset Hound, Cirneco dell'Etna, Kerry Blue Terrier, Bulldog, Chinese Shar-Pei, Chow Chow, Keeshond.

Junior showmanship judges should follow the above.

Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.) 1/31/24

Each Pee Wee unit consists of the child, their responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

A dog must be at least four months of age to enter the Pee Wee class.

- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- Dogs that are allowed: AKC fully recognized, Miscellaneous Class breeds, PAL listings, FSS breeds, and All-American
- A release must be signed by the child's parent or legal guardian. Pee Wee Release of Liability will be available at the show. A time and ring will be listed in the judging program.
- The entry fee has been waived by the club. There is no cost for this event. Entries will be accepted on the day of the event.
- The safety of the dog and child inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.
- Although the word “judge” will be used, this is designed to be learning and mentoring experience. No Junior will be “judged”, but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation ribbon to commemorate the experience. There is no pre-entry, but we would like to know the number of Pee Wee Participants to expect. Please send an email with the participant's name and adult's name by March 13th, 2024. A luncheon for both the participant and adult will be served.

Best of Breed/Variety Competition - "The following categories of dogs may be entered and shown in Best of Breed competition - Dogs that are Champions of Record- Dogs which, according to their owner's records, have completed the requirements for a championship but whose championships are unconfirmed, provided this transfer is made in writing and presented to the superintendent at least 30 minutes prior to the start of each trial. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES

Stud Dog Class - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

SATURDAY & SUNDAY NOHS JUDGING

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.

- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.

- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.

- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.

- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.

- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.

- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years*

****A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS. .AKC Revised 5/11/18**

BRED-BY-EXHIBITOR • SATURDAY • BREED, GROUP, BEST IN SHOW

Competition is offered for dogs & bitches entered and exhibited in the bred-by-exhibitor classes of each age group to compete for Best of Breed Bred-By-Exhibitor through Best in Show Bred- By-Exhibitor. Dogs that win Best of Breed or Best of Winners from a Bred by Exhibitor class in the regular conformation classes are automatically Best of Breed Bred-By-Exhibitor.

Open to dogs & bitches entered in the Bred-by-Exhibitor Class on Saturday.

Bred by Exhibitor Classes Divided, both Sexes: 6-12 Mos., 12 Mos. & Older Competition for Best of Breed Bred-by-Exhibitor will be held after the completion of each breed. The schedule for Bred-by-Exhibitor group time and judge will be published in the judging program. Competition for Best in Show Bred-by-Exhibitor will take place just prior to the regular Best in Show judging. Entry for Best of Breed Bred-by-Exhibitor is automatic for dogs & bitches that win first place in the regular Bred-by-Exhibitor Class. Throughout competition, dogs & bitches must be shown by persons eligible for the Bred-by-Exhibitor Class as defined in Chapter 3, Section 7, of the Rules Applying to Dog Shows published by The American Kennel Club. In the event the Best of Breed or Best of Winners is awarded to a dog or bitch that was first in the Bred- by-Exhibitor class that dog or bitch will automatically be the Best of Breed Bred-by-Exhibitor. If the winner of a Bred-by-Exhibitor Class is not present for Best Bred-by-Exhibitor or Bred-by-Exhibitor Group competition, second place dogs or bitches may not compete in its place.

- Best Bred-By Exhibitor – the Bred-by-Exhibitor class including the Bred-by-Exhibitor Puppy and Bred-by-Exhibitor Adult age divisions. AKC effective 08/20/23

PUPPY • SUNDAY • BREED, GROUP, BEST IN SHOW

Competition is offered for dogs & bitches entered and exhibited in the puppy classes to compete for Best of Breed Puppy through Best in Show Puppy. Puppies that win Best of Breed or Best of Winners in the regular conformation classes are automatically Best of Breed Puppy.

Open to dogs & bitches entered in the Puppy Classes (6-9 mos. & 9-12 mos.) on Sunday. Each Best of Breed Puppy will compete in its own Puppy Group, judged in the same fashion as the Regular Group & the seven Puppy Group Winners will then compete for Best Puppy in Show. Any Puppy Class dog that is awarded Best of Breed or Best of Winners will automatically be awarded Best of Breed Puppy. The Group & Best in Show Puppy judges will be published in the judging schedule. Group time will be announced on the day of the show.

- Best Puppy – any class limited to dogs six months and older and under 12 months of age; Puppy, 6-9 Puppy, 9-12 Puppy, and Bred-by-Exhibitor Puppy. AKC effective 08/20/23

VETERAN ALTERED SPECIAL ATTRACTION • SATURDAY • BREED, GROUP, BEST

Competition is offered for dogs & bitches who enter and exhibit in the Veteran Altered Special Attraction competition. Open to dogs & bitches that are spayed or neutered and who are at least 7 years old.

Each entrant will receive a round of applause in a show ring. Judge, time, and location will announced in the judging program. An entry form is required. The class must be listed as “VETERAN ALTERED SPECIAL ATTRACTION”. Entry fee and deadlines must be followed.

Order of judging: Breed judging, divided by sex, for the special attraction will take place in the breed ring directly following the completion of the regular judging for the breed. One winner will be selected per breed. The breed winner goes on to compete in group competition and the group winners advance to best.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Novice Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Novice Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Open Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Master Class: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors Meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Each dog handled in a Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC, go online at www.akc.org.

Junior Handler's must include their AKC Junior Handler identification number on the entry blank. You may obtain your number by calling the AKC Event Records Department (919) 233-9767.

Notice: Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.

Upon appropriate notification including a copy of a document verifying registration in one of the aforementioned shows, the SSKC will disperse the \$500.00 scholarship money directly to the recipient. For Attendance at an accredited, approved, post-secondary educational institution:

Upon appropriate notification including a copy of a document of registration and a point of contact at the post-secondary educational institution, the SSKC will disperse the scholarship money directly to the recipient's institution of choice OR with appropriate receipts the \$500.00 may be dispersed to the student directly for books, academic supplies and/or materials at the discretion of the SSKC Board of Directors.

Definitions & Limitations:

The recipient must redeem the Scholarship Certificate(s) by age 18 if using it to enter & participate in any of the aforementioned dog shows.

If used for higher education, the recipient must redeem the Scholarship Certificate(s) by age 25 or the monies will be forfeited and placed back into the Silver State Kennel Club Scholarship Fund.

1. Entries must reach the Superintendent, Jack Bradshaw, 320 Maple Avenue, Torrance, CA 90503, by Noon, Wednesday March 13, 2024 PT. Fees should accompany entries. This club and/or its superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.
4. During the hours of judging owners or their handlers are to be on call, and have their dogs ready to bring into the judging ring promptly. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. 5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rulebooks are available online at www.akc.org
7. The club, its superintendents or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler.
