The following breeds may be judged on the ground, table or ramp: Whippets, Miniature Bull Terriers.

The following breeds may be judged on the ground or ramp: Boykin Spaniels.

As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

**Brood Bitch Class** – For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

When filling out entry forms, include achievement level and age division. Example: Novice Junior

**Novice.** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**Open.** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior Handler wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

**Reserve Best Junior Handler** An all-breed club offering Junior Showmanship shall offer Reserve Best Junior Handler, a Group Club or Specialty Club has the option to offer Reserve Best Junior. After the judge has awarded the Best Junior Handler, the second-place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. **BITCHES IN SEASON ARE NOT ELIGIBLE.** A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

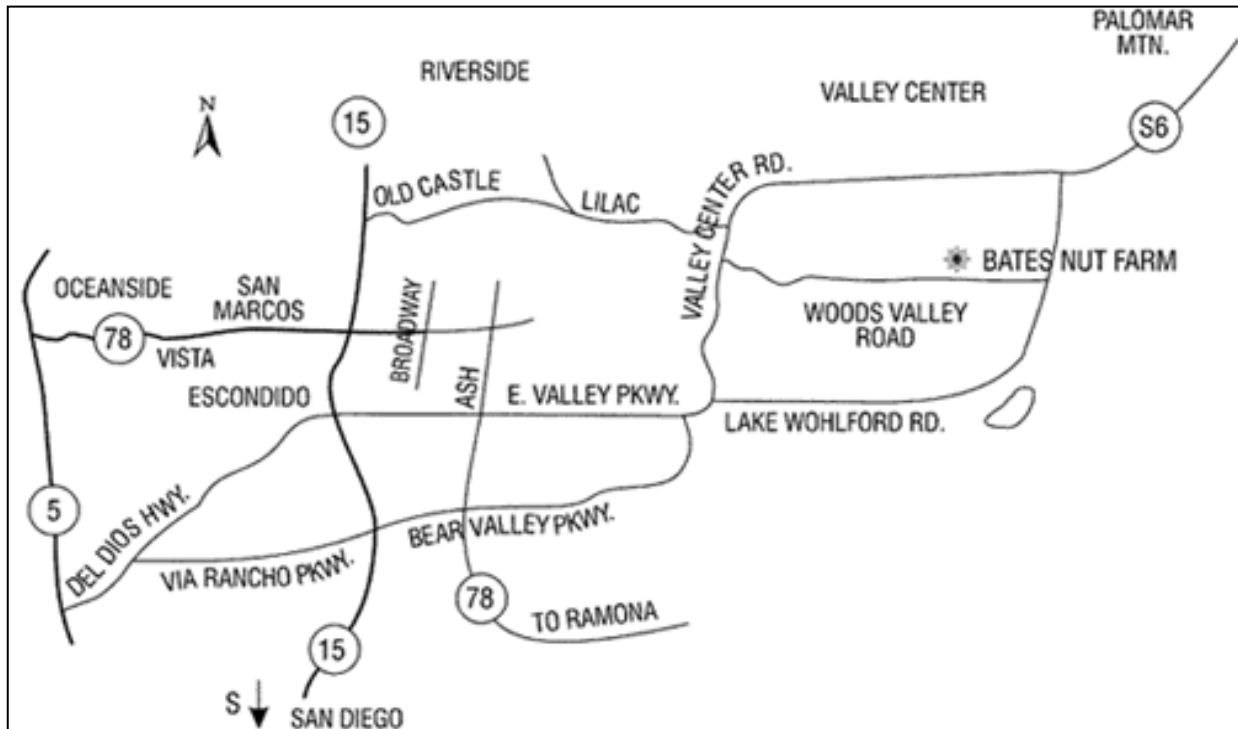

Each Pee Wee unit consists of the child, their responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- Dogs that are allowed: AKC fully recognized, Miscellaneous Class breeds, PAL listings, FSS breeds, and All-American
- A release must be signed by the child's parent or legal guardian. Pee Wee Release of Liability will be available at the show. A time and ring will be listed in the judging program.
- The entry fee has been waived by the club. There is no cost for this event. Entries will be accepted on the day of the event.
- The safety of the dog and child inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience. No Junior will be "judged", but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation ribbon to commemorate the experience.

#### Section 1– Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

#### Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.

- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

## NATIONAL OWNER-HANDLED SERIES – Saturday and Sunday

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

**Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS. AKC Revised 5/11/1*

The following plan is designated at this time for the Del Sur Kennel Club, Inc. (DSKC) All Breed Dog Shows, Obedience and Rally Trials and Participating Breed Club Specialty Events. This plan is subject to change as circumstances may dictate.

1. **PLEASE STAY HOME.** If you are ill, feel unwell, are coughing, sneezing or running a temperature.
2. **EXPOSURE TO COVID-19:** If you have recently been in the presence of a person who has either tested positive for Covid-19 or has the symptoms (coughing/sneezing/temperature) please stay home.
3. **MASKS:** *If required by local ordinance at the time of these events*, masks shall be worn at all times while in attendance at these events and shall include all areas of the grounds, including the parking lots – **NO EXCEPTIONS**. No cloth, mesh style masks or neck gaiters are allowed. Face shields may **NOT** be worn in place of a mask, but may be worn in addition to a mask. Any person found to be in violation of this requirement may be asked to leave the grounds and/or face disciplinary action.
4. **FORCE AIR DRYERS:** Although not anticipated at this time, *if their use is restricted by local ordinance at the time of these events*, will not be allowed anywhere on the show site, including parking lots. You may wish to bring a handheld hair dryer just to be prepared.
5. **SET-UPS AND UNLOADING:**
  - a. Unloading zone will open at 6:15 am.
  - b. All vehicles are to be removed to the parking lot as soon as they are unloaded.
  - c. Personal tents and generators will only be allowed in designated areas. No individual setups will be allowed within the ring area.
  - d. No exercise pens under Club supplied tents.
  - e. No exercise pens or set-ups within 20 feet of the rings or in the Fire Lanes.
  - f. No exercise pens or set-ups in any Day of Show Parking lot.
  - g. All dogs on grooming loops must be attended at all times.
  - h. No vehicles or vehicle traffic will be allowed on the show grounds for loading or unloading.
6. **RINGS:** To minimize the number of persons near the rings at any one time, be aware of, and adhere to your scheduled judging time. Do not arrive at your designated location more than 15 minutes prior to your scheduled time and exit the area immediately upon completion of your participation. Do not congregate at, or block, ring entrances and exits.
7. **STAGING AREA:** A designated staging area will be provided for Obedience and Rally. Please remain in this area and maintain social distancing until your number is called to the ring.
8. **ARM BANDS:** Please know your Armband Number when you arrive at the table. Arrange to pick up all armbands at the same time and, if possible, arrange for one individual to collect the armbands for various individuals. Maintain social distancing while waiting for your armbands. Catalogs at these tables will not be available for your use, but only the use of the individuals assigned to issue the armbands. If you need to label the armbands for particular dogs, please bring your own pen as pens will not be available for use.
9. **RINGSIDE CHAIRS:** DSKC will not provide for any seating around the rings but exhibitors may bring their own chairs. *If required by local ordinance at the time of these events*, social distancing between each other and from the rings must be maintained. While household units may sit together, group gatherings or congregating under the tents or ringside may not be allowed. No chairs may be left under club provided tents or at ringside overnight.
10. **RING PROCEDURES:** *If required by local ordinance at the time of these events*, judges, stewards and exhibitors may be required to wear a mask at all times while exhibiting. Failure of exhibitors to adhere to this policy could cause them to be excused from the ring and may result in disciplinary action.
11. **RING TENTS:** The DSKC tents at ringside are meant for the use of the breed scheduled for the ring during that time. Do not arrive at your assigned ring any earlier than 15 minutes prior to your assigned time. In order to maintain social distancing, tent space should be yielded to the breed currently in the ring. Please vacate the DSKC ring tents as you complete showing in your designated class, unless you will be returning to the ring for “winners” or “breed”. Crates are discouraged under these tents but if you do bring a crate for multiple dogs, they must be removed when you complete showing in your class.

12. **ENTRY TO THE RINGS:** *If required by local ordinance at the time of these events*, exhibitors will line up outside the ring maintaining social distancing and will be called into the ring as each judge deems appropriate. The judge will direct you as to how to prepare your dog for exam. Follow the judge's directions. Judges will have hand sanitizer and/or gloves available between examinations. When gaiting with other exhibitors, maintain a distance between exhibits. After placements are made, leave the ring and if you are not going forward in the judging of that breed, please leave the ring and tented area. There will be a separate entrance and exit for each ring, please use these appropriately. The judge or steward will direct those who are going forward as to where they are to wait for winners or BOB judging.
13. **GROOMING:** *If required by local ordinance at the time of these events*, there may be limitations on the use of blow dryers. Grooming space may be limited as the need for social distancing and may require spacing between spots.
14. The Show Site will be available to exhibitors after 2:00PM on Thursday. Dogs and vehicles must be removed from the show site immediately following Best in Show judging on Sunday.
15. No practicing allowed in the rings at any time.
16. No dogs are to be left overnight.
17. Each exhibitor is responsible for cleaning up after their own dog(s). If your dog soils in the show ring, the ring steward will hold your dog while YOU do the clean-up. Poop bags will be placed outside each ring.
18. Responsible dog owners will clean up after their dog(s) at all times.
19. All stand-alone ex-pens **MUST** have someone in attendance with them at all times.
20. **PARENTS SHALL BE RESPONSIBLE FOR THEIR CHILDREN AT ALL TIMES!**
21. **NO SKATEBOARDS, ROLLERBLADES, SCOOTERS OR BIKES WILL BE ALLOWED ON THE SHOW GROUNDS, INCLUDING OVERNIGHT AND DAY-OF-SHOW PARKING LOTS DURING SHOW HOURS.**
22. **NO UNAUTHORIZED USE OF MOTORIZED VEHICLES ON SHOW GROUNDS DURING SHOW HOURS.**
23. Grooming and exercise pens in **DESIGNATED AREAS ONLY**. Crates may be brought to ringside during breed judging and must be removed immediately when judging for that breed is over.
24. **NO GROOMING OR SMOKING UNDER SHADE TENTS OR IN THE AISLES. ALL CRATES MUST BE REMOVED FROM RINGSIDE AND FROM UNDER SHADE TENTS IMMEDIATELY AFTER YOU ARE DONE SHOWING.**
25. **FREELANCE PHOTOGRAPHY** will **ONLY** be allowed on the show grounds of the Del Sur Kennel Club shows with prior written permission of the Show Chair. No exceptions.
26. **PUBLICATION RIGHTS** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to Del Sur Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition. 11/21/18
27. No peddling, soliciting, delivery of merchandise or passing out publications or literature of any type on the showgrounds without the written permission of the Del Sur Kennel Club.

All persons attending this dog show/event, hereby waive any claim for damages against Del Sur Kennel Club, its members, employees or volunteers in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. Section V, page 6 of the Dealing With Misconduct booklet states: "When a dog is seriously injured or dies in connection with an event, the Event Committee must conduct a Preliminary Investigation to determine if negligence or willful conduct of an individual caused the injury or death." This section also requires a written report.

## ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw by **Noon, Wednesday, April 13, 2022 PT**. Fees should accompany entries. This club and/or its superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check or declined credit card **MUST BE MADE GOOD** by cash or money order **BEFORE** the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. Tickets returned by the Post Office marked 'undeliverable' will be held at the Superintendent's Office. **PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.**
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, or of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club or of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 7 a.m. to 7:00 p.m.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available online at [www.akc.org](http://www.akc.org).
7. The club, its superintendents, volunteers or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitors' setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club. No exercise pens allowed in any buildings.
9. Entry fees shall **NOT** be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$4.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at this show.
11. Declination of Entries. The Del Sur Kennel Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
12. If, because of riots, civil disturbances, inclement weather or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one-half hour prior to the start of the earliest Conformation judging at the Show.
15. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
16. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the superintendent at least 30 minutes prior to the start of each trial.
17. No practicing is allowed in the rings at any time.
18. Parents and/or Guardians are responsible for the actions of their children.
19. **NO UNAUTHORIZED VEHICLES** shall be operated in the aisles between rings or within 20 feet of any ring. Private golf carts will be restricted to the outside perimeter of the Show Boundaries designated as the Fire Lanes.
20. Bitches in season are ineligible to compete in Obedience or Rally trials. To receive a refund, owners of bitches in season need to present a veterinarian's letter to the Superintendent no later than one half hour prior to the start of the first class in the trial. There will be a \$2.00 fee charged for bitch in season refunds.
21. By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present and agree not to hold Jack Bradshaw Dog Shows, Del Sur Kennel Club, Bates Nut Farm its owners, employees, or volunteers liable for any illness or injury.
22. By attending this event, you voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Jack Bradshaw Dog Shows, Del Sur Kennel Club, Bates Nut Farm its owners, employees, or volunteers liable for any illness or injury.
