At the discretion of the judge, the following breeds may be examined on a ramp through all levels of competition: Nova Scotia Duck Tolling Retriever, American Water Spaniel, Boykin Spaniel, Field Spaniel, Welsh Springer Spaniel, Basenji, Grand Basset Griffon Vendéen, Norwegian Elkhound, Whippet, German Pinscher, Portuguese Water Dog, Standard Schnauzer, American Staffordshire Terrier, Irish Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terrier, Finnish Spitz, Australian Cattle Dogs, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdog, Mudi, Norwegian Buhund, Polish Lowland Sheepdog, Puli, Norrbottenspet.

The following breeds may be examined on the ground, table or ramp: Miniature Bull Terrier.

Breeds not listed above are to be judged on the ground. Junior showmanship judges should follow the above.

As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

**Brood Bitch Class** – For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

**Novice.** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**Open.** This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior Handler wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

**Reserve Best Junior Handler** An all-breed club offering Junior Showmanship shall offer Reserve Best Junior Handler, a Group Club or Specialty Club has the option to offer Reserve Best Junior. After the judge has awarded the Best Junior Handler, the second-place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. **BITCHES IN SEASON ARE NOT ELIGIBLE.** A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship.

Each Pee Wee unit consists of the child, their responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- Dogs that are allowed: AKC fully recognized, Miscellaneous Class breeds, PAL listings, FSS breeds, and All-American.
- A release must be signed by the child's parent or legal guardian. Pee Wee Release of Liability will be available at the show. A time and ring will be listed in the judging program.
- The entry fee has been waived by the club. There is no cost for this event. Entries will be accepted on the day of the event.
- The safety of the dog and child inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience. No Junior will be "judged", but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation ribbon to commemorate the experience.

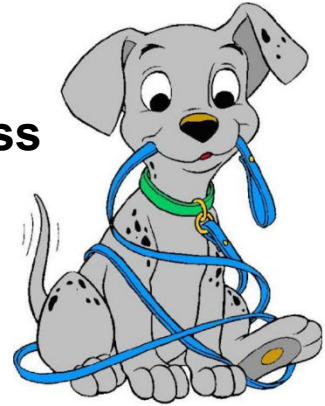

## 4-6 Month Beginner Puppy Class

Entry Fee: \$15, per entry



### Regulations:

#### Section 1– Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

#### Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

#### Section 3 – Ribbons

**Fees will be collected at the gate. Please have exact amount ready.**

**NO coins, checks or credit / debit cards will be accepted.**

**ALL RV's and box vans MUST purchase overnight parking space.**

**NO RV's, box vans or set-ups will be allowed in the Day of Show parking area. Sprinter type vans, mini motor homes, or other oversized vehicles, will be parked in a designated area that may not be close to the rings. Violators will be referred to the Bench Committee for disciplinary action.**

Vehicles **MUST** be parked in designated spaces only or they may be towed without notice and at owner's sole expense.

Limited **HANDICAPPED PARKING** is available to those with proper DMV plates or placards. Handicapped parking is to provide easy access and is not necessarily next to the rings. Those found to be using vehicles with handicapped plates or placards not belonging to them in violation of "**§ 4461 VC – Misuse of Handicap Placards or License Plates**" will be cited by the San Diego County Sheriff's Department. Minimum fine is \$250, for a first offense, and up to \$1,000. Violators will also be referred to the Bench Committee for disciplinary action.

Exhibitors will be held responsible for clean conditions in and around their parking space, both during and after the show. Waste water may not be emptied on the grounds or drained into open containers. Violators will be referred to the Bench Committee for disciplinary action.

Reserved setup will start Thursday **after 4:00 PM**, however, your space will be reserved for your arrival on any day of the cluster.

Grooming spaces are reserved. Set up in your space only. If you move your space, or anyone else's, you will be moved to non-reserved grooming, if available.

Electricity is not available anywhere on the grounds. **Quiet, properly maintained and functioning personal generators be may be used in the reserved grooming area in the open (North) end of the arena only.** Anyone plugging into any of the Diane Jacob Lakeside Equestrian Park electrical outlets anywhere on the site will be referred to the Bench Committee for disciplinary action.

No x-pens will be allowed in the arenas. Arena may be watered down nightly after judging is completed, please plan accordingly. Dogs are **NOT** to be left in the arena following daily judging.

## SPECIAL NOTICE to OBEDIENCE & RALLY EXHIBITORS

### IMPORTANT RING and SETUP AREA CHANGES

This year the Obedience and Rally rings will be located underneath the pole barn roof. **Thursday ONLY**, obedience and rally exhibitors will be allowed to drive in to set up in a designated area adjacent the rings **after 4:00 PM**. There will be **NO PARKING** adjacent to this area. Exhibitors will **NOT** be allowed to park on the South side of the exhibition area as was done last year. After setting up, you must move your vehicle to the main parking area. Vehicle access will **NOT** be allowed until the conclusion of all obedience and rally judging on Sunday. **NO EXCEPTIONS!** Violators will be referred to the Bench Committee for disciplinary action and may have their vehicles towed without warning. Anyone arguing with, or using abusive language toward, Equine Event Services staff or DSKC officials, including social media posts, will be referred to the Bench Committee for disciplinary action. There are no provisions for handicapped parking near these rings.

## NATIONAL OWNER-HANDLED SERIES – Friday, Saturday and Sunday

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

**Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS. AKC Revised 5/11/21*

## ADDITIONAL RULES

1. Entries must reach the Superintendent, Jack Bradshaw by **Noon, Wednesday, APRIL 22, 2026 PT**. Fees should accompany entries. This club and/or its superintendent assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This club and its superintendents assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. Returned Checks do not constitute a valid entry fee. The Superintendent will add a collection fee to the amount of each returned check and declined credit card. Subsequent returned checks for the same exhibitors may result in their being put on a **CASH ONLY** basis. The returned check or declined credit card **MUST BE MADE GOOD** by cash or money order **BEFORE** the dog will be allowed in the ring.
3. Exhibitors' Identification tickets and judging programs will be emailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the superintendent. **PLEASE BRING YOUR IDENTIFICATION TICKETS TO THE SHOW.**
4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, or of any agent of the show-giving club to locate any dog, its owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of this club or of The American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 6 a.m. to 10:00 p.m., daily.
5. Trophies and prizes will be awarded in the judging ring before the completion of the judging of the breed and the superintendent's office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
6. Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available online at [www.akc.org](http://www.akc.org).
7. The club, its superintendents, volunteers or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
8. No grooming tables, pens or exhibitors' setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club. No exercise pens are allowed in any buildings or arenas.
9. Entry fees shall **NOT** be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fee for duplicate entry. There will be a \$4.00 fee charged for cancellation of entry prior to closing of entries.
10. There is no provision offered for unentered dogs at this show.
11. Declination of Entries. The Del Sur Kennel Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Del Sur Kennel Club or any official thereof.
12. If, because of riots, civil disturbances, inclement weather or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
13. Do not leave any dogs in closed vehicles.
14. Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent at least one-half hour prior to the start of the earliest Conformation judging at the Show.
15. Junior Handlers who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of the earliest conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
16. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the superintendent at least 30 minutes prior to the start of each trial.
17. No practicing is allowed in the rings at any time.

18. Parents and/or Guardians are responsible for the actions of their children.
19. **NO UNAUTHORIZED VEHICLES** shall be operated in the arena. Private golf carts will be restricted to the outside perimeter of the Show Boundaries designated as the Fire Lanes.
20. Bitches in season are ineligible to compete in Obedience or Rally trials. To receive a refund, owners of bitches in season need to present a veterinarian's letter to the Superintendent no later than one half hour prior to the start of the first class in the trial. There will be a \$2.00 fee charged for bitch in season refunds.
21. By attending this event, you acknowledge that an inherent risk of exposure to COVID-19 and other communicable diseases exists in any public place where people are present and agree not to hold Jack Bradshaw Dog Shows, Del Sur Kennel Club, Diane Jacob Lakeside Equestrian Park, Equine Event Services its owners, employees, or volunteers liable for any illness or injury.
22. By attending this event, you voluntarily assume all risks related to exposure to COVID-19, and other communicable diseases, and agree not to hold Jack Bradshaw Dog Shows, Del Sur Kennel Club, Diane Jacob Lakeside Equestrian Park, Equine Event Services its owners, members, employees, or volunteers liable for any illness or injury.
23. The Show Site will be available to exhibitors after 3:00PM on Thursday. Dogs and vehicles must be removed from the show site immediately following Best in Show judging on Sunday.
24. No dogs are to be left overnight.
25. Each exhibitor is responsible for cleaning up after their own dog(s). If your dog soils in the show ring, the ring steward will hold your dog while **YOU** do the clean-up. Responsible dog owners will clean up after their dog(s) at all times.
26. No stand-alone ex-pens will be allowed in the arenas or in the day of show parking lots.
27. **PARENTS SHALL BE RESPONSIBLE FOR THEIR CHILDREN AT ALL TIMES!**
28. **NO SKATEBOARDS, ROLLERBLADES, SCOOTERS OR BIKES WILL BE ALLOWED ON THE SHOW GROUNDS, INCLUDING OVERNIGHT AND DAY-OF-SHOW PARKING LOTS DURING SHOW HOURS.**
29. **NO UNAUTHORIZED USE OF MOTORIZED VEHICLES ON SHOW GROUNDS DURING SHOW HOURS.**
30. Grooming in **DESIGNATED AREAS ONLY**. Crates may be brought to ringside during breed judging and must be removed immediately when judging for that breed is over.
31. **FREELANCE PHOTOGRAPHY** will **ONLY** be allowed on the show grounds of the Del Sur Kennel Club shows with prior written permission of the Show Chair. No exceptions.
32. **PUBLICATION RIGHTS:** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to Del Sur Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.
33. No peddling, soliciting, delivery of merchandise or passing out publications or literature of any type on the showgrounds without the written permission of the Del Sur Kennel Club.
34. All persons attending this dog show/event, hereby waive any claim for damages against Diane Jacob Lakeside Equestrian Park, Del Sur Kennel Club, Equine Event Services, their members, employees or volunteers in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. Section V, page 6 of the *Dealing With Misconduct* booklet states: "When a dog is seriously injured or dies in connection with an event, the Event Committee must conduct a Preliminary Investigation to determine if negligence or willful conduct of an individual caused the injury or death." This section also requires a written report.

36. **NO DROP-OFF OF DOGS** will be allowed in the overnight parking areas. You must park in the day of show parking lot and then walk your dogs to your handler's space.
