Unloading, Reserved, Officials: From Monroe, turn right onto Avenue 51. There will be signs and personnel to direct you to the respective parking areas.

No Set-Ups allowed in Day of Show Parking Lot

DAY OF SHOW PARKING INFORMATION

There will be unloading areas at each end of the show grounds. Some parking areas may be some distance from your ring(s). Unloading areas will be indicated. The day of show parking area is primarily for people. We are unable to provide transportation for dogs and equipment. If you need the shuttle services, be sure to unload all dogs and equipment from the Unloading Areas.

Please follow the instructions of parking attendants. The time limit in the unloading/loading areas is 20 mins. With no exceptions. Day-of-Show parking will be **\$20.00** per parking space. NO Vehicles requiring more than one space (motor homes, Oversized vehicles or trailers etc.) allowed in the Day-of-Show or Overflow parking lot.. No overnight parking will be allowed in the Day of Show parking lots. Anyone not following KCPS rules or parking attendance instructions risks having his/her vehicle towed at owners' expense without parking announcement.

Towing Policy Cars parked in the unloading zone for more than 20 minutes will be towed without any public announcement. Towed vehicles can be picked up at -Plaza Towing . 760-775-4314

ATTENTION EXHIBITORS

The use of Flexi-leads is not permitted on the show grounds, except in the Obedience warm-up ring. Flexi-leads are not allowed on the show grounds during show hours.

All grooming is to be done in provided areas away from the rings.

No unattended soft crates will be allowed on the show grounds. All power-driven convenience devices used on the show grounds must display a KCPS certificate of proof of insurance. Other power-driven mobility devices (OPDMD) as defined by the ADA are exempt from KCPS certification.
